I refer to each of the State's Regional Development Commissions, and I ask:

- (a) how many employees by headcount and FTE are employed by or appointed for the service of each commission;
- (b) of those identified in (a), how many are:
 - (i) permanent employees;
 - (ii) casual employees; and
 - (iii) employees of another type or category (please detail); and
- (c) of those identified in (a), how many permanently reside in:
 - (i) regional Western Australia; and
 - (ii) the Perth metropolitan region?
