# WEDNESDAY, 29 NOVEMBER 2017

# 1. Meeting of Assembly

The Assembly met at 12.00 noon pursuant to adjournment.

The Speaker took the Chair.

Prayers were read.

# 2. Speaker's Statement – Procedure and Privileges Committee – Member Survey

The Speaker advised that the Procedure and Privileges Committee was conducting a short survey examining ways to enhance the functioning of the Legislative Assembly and requested Members to complete and return the survey to the Sergeant-at-Arms.

### 3. Petitions

Helena and Aurora Range – Mr S.A. Millman presented a petition from 1,253 persons requesting that the Legislative Assembly grant full and secure protection to the Helena and Aurora Range through gazettal of the area as an A Class National Park (P. 39).

Community Resource Centres – Petitions requesting that the Legislative Assembly call upon the Premier Mark McGowan to ensure adequate funding to support the ongoing operation of all Community Resource Centres, without reducing service delivery were presented by –

Ms M.J. Davies from 367 persons (P. 40);

Mr P.J. Rundle from 257 persons (P. 48); and

Mr R.S. Love from 198 persons (P. 49).

Aged Care Facility at Carnarvon Hospital – Mr V.A. Catania presented a petition from 604 persons requesting that the Legislative Assembly inquire into the reduced funding allocated to the construction of an Aged Care Facility at Carnarvon Hospital and the two year delay in delivering this essential service (P. 41).

Gnowangerup District High School Principal – Mr P.J. Rundle presented a petition from 229 persons requesting that the Legislative Assembly listen to the School Board, the P&C and the local community and act upon the overwhelming concerns regarding the substantive Principal position (P. 42).

Subiaco East Development – Mr W.R. Marmion presented a petition from 413 persons requesting that the Legislative Assembly calls upon the Minister for Planning, Minister for Local Government and

Minister for Education and Training to intervene and prevent further decisions pertaining to this site being made by the City of Subiaco, pending the outcome of the State Administrative Tribunal (SAT) and related Supreme Court writ (P. 43).

Subiaco East Development – Mr W.R. Schedule indicating the amendments made by the Legislative Council in the First Home Owner Grant Amendment Bill 2017

#### No. 1

New Clause 11A, page 5, after line 30 — To insert:

#### 11A. Section 26 amended

In section 26 in the definition of *decision on the application*:

- (a) in paragraph (d) delete "(3);" and insert:
  - (3); and
- (b) after paragraph (d) insert:
  - (e) a requirement under section 52A(1) to pay an amount of legal costs incurred by the Commissioner.

#### No. 2

New Clause 12A, page 6, after line 17 — To insert:

#### 12A. Section 30 amended

After section 30(5) insert:

- (6) If, as the result of a decision on an objection, an amount of legal costs paid by an applicant is to be repaid to the applicant, the following amounts are payable to the applicant
  - (a) the amount of legal costs to be repaid;
  - (b) any interest paid by the applicant in respect of a written arrangement approved by the Commissioner under section 52 that relates to an amount referred to in paragraph (a);
  - (c) interest at the prescribed rate on the amounts payable to the applicant under paragraphs (a) and (b) from the date the amount was paid by the applicant to the date approved for the repayment.

New Clause 12B, page 6, after line 17 — To insert:

#### 12B. Section 32 amended

After section 32(4) insert:

- (5) If, as the result of an application for a review of a decision, an amount of legal costs paid by an applicant is to be repaid to the applicant, the following amounts are payable to the applicant
  - (a) the amount of legal costs to be repaid;

- (b) any interest paid by the applicant in respect of a written arrangement approved by the Commissioner under section 52 that relates to an amount referred to in paragraph (a);
- (c) interest at the prescribed rate on the amounts payable to the applicant under paragraphs (a) and (b) from the date the amount was paid by the applicant to the date approved for the repayment.

Clause 15, page 8, line 15 — To insert after "pay the":

reasonable

#### No. 5

Clause 15, page 8, after line 22 — To insert:

- (3) If the notice covers legal costs as defined in the *Legal Profession Act 2008* section 3
  - (a) the notice must include or be accompanied by a written statement setting out the applicant's right under the *Legal Profession Act 2008* to apply for an assessment of those costs; and
  - (b) the Commissioner must not commence proceedings to recover those costs until at least 30 days after the date on which the notice is given to the applicant.
