# FIRST SESSION OF THE THIRTY-EIGHTH PARLIAMENT

# **WEDNESDAY, 18 NOVEMBER 2009**

### 1. Meeting of Assembly

The Assembly met at 12.00 noon pursuant to adjournment.

The Speaker took the Chair.

Prayers were read.

#### 2. Petitions

Urban Development South of Moore River - Petitions requesting that the Legislative Assembly support the recommendation that the land adjoining the proposed Wilbinga Conservation Park be protected from future development were presented by –

Mr C.J. Tallentire from 179 persons (P. 181); and

Mr G.A. Woodhams from 20 persons (P. 182).

Shack Site Communities - Mr G.A. Woodhams presented a petition from 248 persons requesting that Shack Site communities be preserved so Western Australians have affordable coastal holiday destinations for future generations (P. 183).

The Minister for Planning moved, That the bill be now read a second time.

Ms R. Saffioti moved, That the debate be adjourned.

Question put and passed.

#### 7. Criminal Code Amendment (Identity Crime) Bill 2009

The Attorney General, pursuant to notice, moved,

That a bill for "An Act to amend *The Criminal Code*." be introduced and read a first time.

Question put and passed.

The Attorney General presented an explanatory memorandum and bill read a first time.

The Attorney General moved, That the bill be now read a second time.

Ms R. Saffioti moved, That the debate be adjourned.

Question put and passed.

#### 8. Criminal Code Amendment Bill (No. 2) 2009

The Attorney General, pursuant to notice, moved,

That a bill for "An Act to amend *The Criminal Code*." be introduced and read a first time.

Question put and passed.

The Attorney General presented an explanatory memorandum and bill read a first time.

The Attorney General moved, That the bill be now read a second time.

Mr M. McGowan moved, That the debate be adjourned.

Question put and passed.

#### 9. Public Sector Commissioner

The Premier, pursuant to notice, moved,

That in accordance with sections 18(6) and 28 of the *Public Sector Management Act 1994*, this House authorises Malcom Charles Wauchope to continue to hold the office of Public Sector Commissioner, being an office referred to in Part 1 of Schedule V of the *Constitution Acts Amendment Act 1899*, upon an appointment by the Governor of him as Acting Commissioner for Public Sector Standards, and requests the Legislative Council to agree to a similar resolution.

Debate ensued.

The Leader of the House moved, That the debate be adjourned until a later stage of this day's sitting. Question put and passed.

### 13. Matter of Public Interest - Government Wages and Funding Cuts

The Speaker informed the Assembly that he was in receipt of a notice from Mr E.S. Ripper that he intended to move a motion on a matter of public interest.

Speaker's Ruling - Format for Matter of Public Interest

The Speaker ruled that the Matter of Public Interest about to be put before the House would be deemed in order in this instance; however, members were reminded of Standing Order 145 which states that a Matter of Public Interest should only contain one topic for debate.

At least five members having risen in support,

## Mr E.S. Ripper moved,

That this House condemns the Barnett Government for its lack of care and compassion towards those Western Australians most in need including:

- 1. its failure to support the state's education assistants, gardeners and cleaners secure a fair pay increase; and
- 2. its decision to cut Redress WA funding at a time when the Federal Government and Opposition has apologised and recognised the struggle of those abused in care.

Debate ensued.

The Leader of the House moved,

To delete all words after "House" and substitute –

"supports decent and fair pay rates for education assistants, gardeners and cleaners employed in cleaning government buildings and offices and also supports the fair and equitable distribution of the funds allocated for the original Redress WA scheme to all eligible applicants."
