1. Meeting of Assembly

The Assembly met at 9.00 a.m. pursuant to adjournment.

Skilled Local Jobs Bill 2011 – Mr E.S. Ripper presented a petition from 154 persons requesting that the Legislative Assembly urge all members to support the Skilled Local Jobs Bill 2011 with the objective of ensuring that a greater share of skilled work for major resources projects is performed in Western Australia (P. 441).

Lot 211 Wandoo Street Mt Nasura – Dr A.D. Buti presented a petition from 32 persons requesting that the Legislative Assembly take action to restore Lot 211 Wandoo Street, Mt Nasura to its original purpose as a Reserve. (P. 442).

Midland Train Line – Ms L.L. Baker presented a petition from 171 persons requesting that Legislative Assembly ensures that the Barnett Government addresses overcrowding on the Midland train line, similar to action taken on the Joondalup and Mandurah train lines (P. 443).
