1. Meeting of Assembly

The Assembly met at 12.00 noon pursuant to adjournment.

The Speaker took the Chair.

Prayers were read.

2. Death of Rex Geoffrey Williams – a former Member of the Legislative Assembly

The Premier, without notice, moved,

That this House records its sincere regret at the death of Rex Geoffrey Williams and tenders its deep sympathy to his family.

The motion was supported by Mr M. McGowan and Mr D.T. Redman.

Question put and passed unanimously with members and officers of the Assembly standing in their places as a mark of respect.

3. Petitions

Prostitution Bill 2011 – Mr P. Abetz presented a petition from 124 persons requesting that the Legislative Assembly fully investigates the Swedish law and commits to phasing out all brothels (P. 606).

Smart Rider Terminal Kelmscott – Dr A.D. Buti presented a petition from 339 persons requesting that a Smart Rider terminal at Kelmscott Newsagency, situated at the Kelmscott Village Shopping Centre, be provided (P. 607).
