I refer to the review into fire safety systems at aged care facilities, which the WA Seniors Alliance was advised commenced in 2018, and ask:

- (a) has the review been completed and if so, will you table a copy of the same; and
- (b) if the review has not been completed can you please advise:
 - (i) why there has been such a significant delay in undertaking the review;
 - (ii) what work has been done to date; and
 - (iii) when the review will be finalised?

- (b) Does the McGowan Government have a policy that gives direction to media advisors in respect to making formal complaints to media outlets; and
- (c) Is it policy or practice for Ministers to be informed of their respective media advisors making formal complaints to media outlets on matters to do with portfolio media activity?
