THURSDAY, 18 OCTOBER 2018

1. Meeting of Assembly

The Assembly met at 9.00 am pursuant to adjournment.

2. Petitions

Crown Land Lot 9789 in Alfred Cove – Mrs L.M. O'Malley presented a petition from 27 persons requesting that any sale of Crown Land Lot 9789 to the City of Melville be rejected (P. 109).

Royal George Hotel Site – Ms S.F. McGurk presented a petition from 387 persons requesting that the Minister for Planning and the Western Australian Planning Commission approves the Town of East Fremantle's Local Planning Scheme No. 3 Amendment No. 13 in its current form relating to the Royal George Hotel Site at 34 Duke Street, East Fremantle (P. 110).
