#### 16. Message from the Legislative Council

Message No. 200 dated 1 December 2011 from the Legislative Council was reported as follows -

The Legislative Council acquaints the Legislative Assembly that it has passed the following resolution, proposing amended terms of reference for the Joint Delegated Legislation Committee –

That the Legislative Assembly be acquainted that the Legislative Council has adopted proposed Schedule 1, Item 6, *Joint Delegated Legislation Committee*, and invites the Legislative Assembly to concur.

#### **SCHEDULE**

#### 6. Joint Delegated Legislation Committee

- 6.1 A *Joint Delegated Legislation Committee* is established.
- The Committee consists of 8 Members, 4 of whom are appointed from each House. The Chair must be a Member of the Committee who supports the Government.
- 6.3 A quorum is 4 Members of whom at least one is a Member of the Council and one a Member of the Assembly.
- 6.4 (a) A report of the Committee is to be presented to each House by a Member of each House appointed for the purpose by the Committee.

- (b) Where a notice of motion to disallow an instrument has been given in either House pursuant to recommendation of the Committee, the Committee shall present a report to both Houses in relation to that instrument prior to the House's consideration of that notice of motion. If the Committee is unable to report a majority position in regards to the instrument, the Committee shall report the contrary arguments.
- 6.5 Upon its publication, whether under section 41(1)(a) of the *Interpretation Act 1984* or another written law, an instrument stands referred to the Committee for consideration.
- 6.6 In its consideration of an instrument, the Committee is to inquire whether the instrument
  - (a) is within power;
  - (b) has no unintended effect on any person's existing rights or interests;
  - (c) provides an effective mechanism for the review of administrative decisions; and
  - (d) contains only matter that is appropriate for subsidiary legislation.
- 6.7 It is also a function of the Committee to inquire into and report on -
  - (a) any proposed or existing template, *pro forma* or model local law;
  - (b) any systemic issue identified in 2 or more instruments of subsidiary legislation; and
  - (c) the statutory and administrative procedures for the making of subsidiary legislation generally, but not so as to inquire into any specific proposed instrument of subsidiary legislation that has yet to be published.
- 6.8 In this order –

"instrument" means -

- (a) subsidiary legislation in the form in which, and with the content it has, when it is published;
- (b) an instrument, not being subsidiary legislation, that is made subject to disallowance by either House under a written law;

"subsidiary legislation" has the meaning given to it by section 5 of the *Interpretation Act* 1984.

Ordered, That consideration in detail of Legislative Council Message No. 200 be made an Order of the Day for the next sitting of the Assembly.

Mrs M.H. Roberts moved, That the following words be added:

and that this House calls upon the Premier to establish an independent judicial inquiry into the September 2011 Kimberley Ultramarathon. Terms of reference for such an inquiry should include, but not be limited to, the following:

- (1) all events and arrangements that were made prior, during and after the event that may have caused, contributed to or worsened the injuries that were sustained by Kate Sanderson, Turia Pitt, Michael Hull, Martin Van Der Merwe and others;
- (2) the appropriateness of the arrangements or any contract between RacingThePlanet and Eventscorp or WA Tourism or the Minister responsible for those agencies;
- (3) the suitability of RacingThePlanet and its staff to manage such an event;
- (4) the adequacy or otherwise of safety arrangements for event participants and others;
- (5) the adequacy or otherwise of medical evacuation procedures for the event;
- (6) the adequacy or otherwise of communications for the event;

- (7) insurance and civil liability matters; and
- (8) the role of WA Government Departments or agencies including, but not limited to, Eventscorp, WA Tourism, CALM, FESA, Police and Health.

Debate ensued.

Amendment, by leave, withdrawn.

On the question, That the Premier's Statement be noted,

Debate resumed.

The Leader of the House moved, That the debate be adjourned.

Question put and passed.

The Leader of the House moved, That the House do now adjourn.
