The despatch from the President of the Senate reads as follows:

The Honourable Kim Beazley AC Governor of Western Australia

Your Excellency

Pursuant to the provisions of section 21 of the Commonwealth of Australia Constitution, I notify Your Excellency there is a vacancy in the representation of the State of Western Australia caused by the resignation of Senator Rachel Siewert on Monday, 6 September 2021.

Yours sincerely Scott Ryan 7 September 2021

The Premier, pursuant to the Message from His Excellency the Governor, moved –

That Madam Speaker be requested to confer with the President of the Legislative Council, in order to fix a day and place whereon and whereat the Legislative Assembly and the Legislative Council, sitting and voting together, shall choose a person to hold the place of the Senator whose place has become vacant.

Question put and passed.
