CONSIDERATION IN DETAIL

Clause 7.

The Minister for Water moved,

Page 4, lines 15 to 17 — To delete "must not be less than 25% of the forecast levy amount for the financial year." and substitute:

۲,

must be as follows —

- (a) in the financial year ending 30 June 2010 an amount not less than the difference between 25% of the forecast levy amount for that financial year and the amount of levy paid or payable for the period 1 July 2009 to 31 December 2009;
- (b) in any other financial year not less than 25% of the forecast levy amount for the financial year.

Deputy Speaker's Ruling - Test Vote

The Deputy Speaker advised members that two members had indicated a wish to move amendments to Clause 7 of the *Waste Avoidance and Resource Levy Amendment Bill 2009*.

The Minister for Water's amendment to Clause 7 was to delete certain words on page 4, lines 15 to 17 with a view to substituting other words. The member for Fremantle wished to delete certain words in line 16.

If the House was to delete all of the words proposed to be deleted by the Minister for Water, it would effectively prevent the member for Fremantle from moving her amendment to line 16 of the same Clause, because the words would have been removed from the line and therefore could not be further amended. Hence, a test vote was required.

So as to preserve the rights of both members as far as possible, it was the Deputy Speaker's intention to put only part of the Minister's amendment to delete words up to the point where the member for Fremantle's amendment started, more specifically to delete the words up to and including "than". If that was agreed to by the House, the Deputy Speaker would immediately put the balance of the Minister's proposed deletion.

If the first part of the Minister's amendment was not agreed to, the member for Fremantle was then free to move her amendment.

Question put as a Test Vote, That the words "must not be less than" be deleted.
