5386. Ms L. Mettam to the Minister for Transport:

I refer to the Premier's comments during Legislative Assembly Question Time on 7 August 2019 regarding the cost of Metronet, and I ask:

5387. Ms L. Mettam to the Minister for Transport:

I refer to the Minister's announcement on 4 July 2019 that the McGowan Government would not be proceeding with a value capture model for Metronet, and I ask:

- (a) How will the McGowan Government fund the \$267.1 million windfall, as stated in WA Labor's Metronet policy released during the 2017 March election, given value capture is no longer proceeding?

5388. Ms L. Mettam to the Minister for Transport:

- (1) Are there any capacity constraints on the rail line from Bayswater Station into Perth CBD by adding a third spur line to Ellenbrook?
- (2) What is the maximum number of trains that can run on the Ellenbrook spur line without removing services from the Midland line or Forrestfield line?
- (3) Does the Perth CBD station have the capacity to handle the increased levels of service as a result of the services from the Ellenbrook spur line?
- (4) Are there any required upgrades to stations between Bayswater and the Perth CBD as a result of the Ellenbrook spur line to allow bypassing of stations?

5389. Ms L. Mettam to the Minister for Transport:

I refer to the Premier and Minister's announcement on 4 August 2019 regarding the Morley-Ellenbrook rail line, and I ask:

- (a) How long will it take passengers who board at Ellenbrook Station to arrive at Bayswater Station;
- (b) How long will it take passengers who board at Ellenbrook Station to arrive at Perth CBD Station; and
- (c) What will be the average wait time at Bayswater Station, for passengers who have arrived from Ellenbrook Station, to then board a train to Perth CBD?

5390. Ms L. Mettam to the Minister for Transport:

- (a) When Morley Station opens, how frequently will buses run from the Morley Station to Morley Galleria on:

- (b) If both, what amount is apportioned to the Forrestfield Airport Link project and what amount is apportioned to the Morley-Ellenbrook rail line?

5392. Ms L. Mettam to the Minister for Transport:

- (1) Since 1 April 2019, how much has been raised from the State Government's 10 per cent levy on the turnover of taxis and all authorised on-demand transport?
- (2) If the State Government recoups the targeted \$120 million before the end of the stipulated four year period for which the levy applies, will the McGowan Government cease collecting the levy earlier than planned?

5393. Ms L. Mettam to the Minister for Transport:

Can the Minister please provide a record of all safety incidents since 14 March 2017 related to the Forrestfield Airport Link project including:

- (a) Date of incident;
- (b) Nature of incident;
- (c) Nature of injury;
- (d) Classification of incident; and
- (e) Action taken?

5394. Ms L. Mettam to the Minister for Transport:

I refer to the Forrestfield Airport Link Ministerial Interim Report: Cross Passage Dundas incident and rectification works, dated December 2018:

- (a) Can the Minister please table the final report? If not, why not?

5395. Ms L. Mettam to the Minister for Transport:

I refer to The West Australian article on 9 July 2019 'Worker burned by toxic slurry at troubled Forrestfield airport rail link project', and ask:

- (a) On what date and time did this incident occur;
- (b) What was the severity of the injury that occurred;
- (c) What actions were taken to treat the worker's injury;
- (d) What actions have been taken by Salini Impregilo - NRW Joint Venture to ensure this incident does not occur again;
- (e) What actions have been taken by the Public Transport Authority to ensure this incident does not occur again; and
- (f) Was the Minister aware of this as a potential health and safety risk, prior to the incident occurring?

5396. Ms L. Mettam to the Minister for Transport:

I refer to the Northern Section (Ellenbrook to Muchea) of NorthLink WA, and I ask:

- (a) Since 14 March 2017, have there been any delays to the estimated completion date of the northern section of NorthLink WA;
- (b) If yes, what were the reasons for the delays;
- (c) If yes, on what date was the Minister advised of the delays; and
- (d) What is the current estimated completion date of this section?

5397. Ms L. Mettam to the Minister for Transport:

I refer to the Northern Section (Ellenbrook to Muchea) of NorthLink WA, and I ask:

- (a) Is the Public Transport Authority, the Department of Transport, or a contractor responsible for the certification of sand compacting related to this project;
- (b) Which engineer certified the sand compacting, and on what date;
- (c) Are there any issues with sand compaction related to this project;
- (d) If yes, what are the issues and how are they being rectified; and
- (e) If yes, what is the total cost to the taxpayer of rectifying these issues?

5398. Ms L. Mettam to the Minister for Transport:

I refer to the Tonkin Highway-Gnangara Road interchange as part of the NorthLink WA project, and I ask:

- (a) What is the purpose of the small shipping storage container and its contents, located on the side of the road at this interchange;
- (b) On what date did Main Roads WA seek that Western Power connect this interchange to the Western Power grid network;
- (c) Are the traffic lights at this interchange currently connected the Western Power grid network;
- (d) If no to (c) how is Main Roads WA working to rectify this issue; and
- (e) If no to (c):
 - (i) How are they being powered;
 - (ii) Since the traffic lights have been operational, what is the cost of using an alternative power source;
 - (iii) Since the traffic lights have been operational, what is the cost of storage of the alternate power source; and
 - (iv) Which agency is paying these costs?

5399. Ms L. Mettam to the Minister for Transport:

I refer to the Forrestfield-Airport Link project, and I ask:

- (a) Is the Forrestfield–Airport Link project currently on budget;
- (b) If no to (a) what is the current estimated total project cost; and
