(3 petitions)

SYNOPSIS OF BILLS

The following synopsis of Bills dealt with by the Legislative Assembly this week, is intended only to give a brief outline of the purpose of each Bill at the second reading stage of the Bill and the stages it was dealt with in the Legislative Assembly.

Electoral Amendment (Finance and Other Matters) Bill 2023

(Minister for Electoral Affairs) (No. 130)

The purpose of this bill is to amend the *Electoral Act 1907* and to make consequential amendments to the *Adoption Act 1994*, the *Local Government Act 1995* and the *Referendums Act 1983*.

Consideration in detail of Legislative Council Message No. 115.

Amendments 1 to 10 agreed to and the Legislative Council acquainted accordingly.

Health Practitioner Regulation National Law Application Bill 2023

(Minister for Health) (No. 131)

The purpose of this bill is to apply the *Health Practitioner Regulation National Law* (with modifications) as a law of the State; and to repeal the *Health Practitioner Regulation National Law (WA) Act 2010*; and to make consequential amendments to other Acts; and for related purposes.

Bill read a third time and forwarded to the Legislative Council.

Vocational Education and Training Amendment Bill 2023

(Minister for Training) (No. 129)

The purpose of this bill is to amend the *Vocational Education and Training Act 1996*.

Second reading, debated and agreed.

Bill read a third time and forwarded to the Legislative Council.

Planning and Development Amendment Bill 2023

(Minister for Planning) (No. 132)

The purpose of this bill is to amend the *Planning and Development Act 2005*; and make consequential and related amendments to other Acts; and repeal the *Power of Entry and Inspection Regulations*.

Consideration in detail.

Bill read a third time and forwarded to the Legislative Council.

Petroleum Legislation Amendment Bill 2023

(Minister for Mines and Petroleum) (No. 142)

The purpose of this bill is to amend the *Petroleum and Geothermal Energy Resources Act 1967*; the *Petroleum Pipelines Act 1969*; the *Petroleum (Submerged Lands) Act 1982*; and make related and consequential amendments to other Acts.

Introduced and read a first time.

Second reading speech delivered and debate adjourned.

Petroleum and Geothermal Energy Safety Levies Amendment Bill 2023

(Minister for Mines and Petroleum) (No. 143)

The purpose of this bill is to amend the *Petroleum and Geothermal Energy Safety Levies Act 2011*.

Introduced and read a first time.

Second reading speech delivered and debate adjourned.

Residential Tenancies Amendment Bill 2023

(Minister for Housing) (No. 140)

The purpose of this bill is to amend the *Residential Tenancies Act 1987* and to make consequential amendments to the *Residential Parks (Long-stay Tenants) Act 2006*.

Introduced and read a first time.

Second reading speech delivered and debate adjourned.

Casino (Burswood Island) Agreement Amendment Bill 2023

(Minister for Racing and Gaming) (No. 137)

The purpose of this bill is to amend the *Casino (Burswood Island) Agreement Act 1985*.

Introduced and read a first time.

Second reading speech delivered and debate adjourned.

Guardianship and Administration Amendment (Medical Research) Bill 2023

(Attorney General) (LC No. 102)

The purpose of this Bill is to amend the *Guardianship and Administration Act 1990* and the *Guardianship and Administration (Medical Research) Act 2020*.

Second reading, debated and agreed.

Bill read a third time and passed.

Sentence Administration Amendment (Monitoring Equipment) Bill 2023

(Attorney General) (No. 145)

The purpose of this bill is to amend the *Sentence Administration Act 2003*.

Introduced and read a first time.

Second reading speech delivered and debate adjourned.

Climate Change Bill 2023

(Minister for Environment) (No. 139)

The purpose of this bill is to support the reduction of greenhouse gas emissions attributable to Western Australia; and to provide for Western Australia's greenhouse gas emissions reduction targets; and to provide for an emissions reduction strategy, a climate adaptation strategy and sector adaptation plans; and to provide for annual reporting to the Parliament; and for related purposes.

Introduced and read a first time.

Second reading speech delivered and debate adjourned.

Insurance Legislation Amendment (Motor Vehicle Claims Harvesting) Bill 2023

(Parliamentary Secretary to the Treasurer) (No. 138)

The purpose of this bill is to amend the *Motor Vehicle (Third Party Insurance) Act 1943* and the *Insurance Commission of Western Australia Act 1986*.

Introduced and read a first time.

Second reading speech delivered and debate adjourned.

Land Tax Assessment Amendment (Residential Construction Exemptions) Bill 2023

(Parliamentary Secretary to the Minister for Finance) (No. 141)

The purpose of this bill is to amend the *Land Tax Assessment Act 2002*.

Introduced and read a first time.

Second reading speech delivered and debate adjourned.

Legal Deposit Amendment Bill 2023

(Minister for Culture and the Arts) (LC No. 104)

The purpose of this bill is to apply the *Legal Deposit Act 2012*.

Second reading, debated and agreed.

Bill read a third time and passed.

Criminal Investigation Amendment (Protection of Law Enforcement Animals) Bill 2023

(Minister for Police) (No. 128)

The purpose of this bill is to amend the *Criminal Investigation Act 2006*.

Second reading debated and adjourned.

MOTIONS (8)

Only substantive motions are listed below and do not include procedural or formal motions.

Stolen Wages Apology (28/11/23)

The Premier, moved –

That this House formally acknowledges and apologises to Aboriginal and Torres Strait Islander people who worked in Western Australia, between 1936 and 1972, for little or no wages.

Debate ensued.

Question put and passed.

Suspension of Standing Orders – Messages from the Legislative Council

(29/11/23)

The Leader of the House, moved –

That, for the remainder of this year, so much of the Standing Orders be suspended as is necessary to enable Messages from the Legislative Council to be taken into consideration on the day on which they are received.

Question put and passed.

Temporary Order – Amended Sitting Times (29/11/23)

The Leader of the House, moved –

That the following Temporary Order applies for 2024 —

- (1) The House will meet on Tuesdays at 1.00 pm.
- (2) If the House is required to sit beyond 7.00 pm on a Tuesday evening, such as to require a dinner break, the Speaker will advise the House of this before Question Time on that Tuesday.
- (3) Standing Orders are suspended accordingly to the extent necessary to effect these arrangements.

Question put and passed.

Temporary Order – Procedure for Divisions (29/11/23)

The Leader of the House, moved –

That, until the end of 2024, the following Temporary Order in relation to divisions applies —

- (1) Standing Order 137 be amended in suborder (2) by deleting “will not leave the House and”.
- (2) Standing Order 139 be replaced by the following:

Procedure for division

139. When a division has been called for —

- (1) Strangers will withdraw from the Chamber.

- (2) The Speaker will state the question and direct members to exit the Chamber and re-enter through the door behind the Speaker's Chair.
 - (3) The Speaker will direct the 'Ayes' to pass to the right of the Chair and be marked off as they pass by a Clerk at the Clerks' Table and the 'Noes' to pass to the left of the Chair and be marked off as they pass by a Clerk at the Clerks' Table.
 - (4) The Speaker will appoint at least one Teller for each side.
 - (5) The Speaker will order the division bells to be rung for two minutes.
 - (6) After passing the Clerks' Table members will either resume their seat or leave the Chamber.
 - (7) After the two minutes have expired, voting will continue until either the Tellers agree and advise the Speaker that all members present have voted or until a period of one minute has elapsed from the last member to record a vote.
 - (8) After counting the votes the Tellers will sign their respective list, and the Speaker will declare the result of the division.
- (3) Standing Orders 138, 140 and 141 in relation to divisions remain unchanged.
 - (4) Standing Orders are suspended accordingly to the extent necessary to effect these arrangements.

Question put and passed.

Temporary Order – Electronic Petitions

The Leader of the House, moved –

- (1) That the recommendation of the Procedure and Privileges Committee Report No. 5, *Electronic Petitions*, that the Assembly adopt a new Temporary Order regarding e-petitions be agreed to, for a trial period as follows:
 - (a) the trial shall commence on Tuesday, 13 February 2024;
 - (b) any posted period for an e-petition must not extend beyond Sunday, 11 August 2024;
 - (c) the last date for presentation of an e-petition by a Facilitating Member shall be Thursday, 15 August 2024;
 - (d) the trial period, and the Temporary Order, shall expire on Friday, 16 August 2024.
- (2) That the Procedure and Privileges Committee be requested to review the operation of the Temporary Order upon conclusion of the trial period.

Question put and passed.

Temporary Order – Members’ Statements (29/11/23)

The Leader of the House, moved –

That, as a trial until the end of 2024, the following Temporary Order in relation to Members’ statements applies –

- (1) Standing Order 147 be replaced by the following:
Members’ statements

147. Once in each sitting week, at a time decided by the Speaker, the Speaker will call for statements by Members, and up to eight members, other than a Minister, may make a statement not exceeding two minutes each.

- (2) Standing Order 101 is amended in ‘Members’ statements’ by deleting “90 seconds” and substituting “2 minutes” and by deleting “Maximum of 6 members” and substituting “Maximum of 8 members”.
- (3) Standing Orders are suspended accordingly to the extent necessary to effect these arrangements.

Question put and passed.

Teacher Shortages in Western Australia (29/11/23)

Mr P.J. Rundle, moved –

That this House condemns the WA Labor Government for their failure to alleviate teacher shortages and provide a safe and supportive workplace for school staff.

Debated and adjourned.

Frontline Workers and Volunteers in Western Australia (29/11/23)

Mr R.S. Love, moved –

That this House applauds our frontline workers and volunteers who work hard to keep West Australians safe, and notes the WA Labor Government are failing in their promise to do so, instead continuing to disregard the concerns of frontline personnel.

Debate ensued.

The Minister for Police moved, To delete all the words after “safe”.

Debate adjourned.
