### **9. Statement by President — Clerk's Attire**

The President made the following Statement —

I have been in correspondence with the Clerk concerning the formal dress requirements for officers of this House. It is the tradition for officers of this House to wear formal dress similar to that worn by the clerks of the House of Commons.

In 1997, officers in the Council ceased the wearing of wigs. Since that time most parliaments, including the House of Commons, have made changes to their dress requirements for officers.

The wearing of full court dress by our officers no longer reflects parliamentary norms and community expectations and leads to unnecessary cost and discomfort.

Effective from the end of the dinner suspension, officers of the Council will wear a black gown over business attire. Officers may continue to wear traditional dress on ceremonial occasions such as the opening of parliament.
