4194. Mr A. Krsticevic to the Minister for Local Government:

I refer to the Local Government Standards Panel Annual Report 2017-18 and ask of the 15 complaints the body refused to deal with:

- (a) what reasons were provided by the panel for its decision to not deal with the complaints;
- (b) which local governments were involved in those 15 complaints;
- (c) please list the reasons and the relevant local government for the 15 complaints the panel decided not to consider; and
- (d) did any agency or department subsequently deal with the complaints:
 - (i) if yes, which agency and department; and
 - (ii) what were the outcomes of those dealings for each complaint?

4195. Mr A. Krsticevic to the Minister for Local Government:

I refer to the Local Government Standards Panel Annual Report 2017-18 and ask of the 21 complaints found to contain a breach:

- (a) how many complaints were found to contain more than one breach:
 - (i) please list the complaints and the local governments involved; and
 - (ii) please list the breaches, the local governments and council members involved; and
- (b) did the panel find similar breaches from the same council members in any previous panel reports:
 - (i) if yes, please list them, the local governments and council members involved?

4196. Mr A. Krsticevic to the Minister for Local Government:

I refer to the Local Government Standards Panel 2017-18 Annual Report and ask of the 18 complaints that attracted a sanction:

- (a) in which local governments did the 18 complaints originate;
- (b) how many sanctions were imposed;
- (c) please list each local government member sanctioned and each of their breaches;
- (d) how many of the sanctions for breaches were referred to the State Administrative Tribunal:
 - (i) please list the local government members whose breaches were referred to the State Administrative Tribunal; and
 - (ii) please list the breaches overturned by the State Administrative Tribunal;
- (e) how many of the penalties have not been served:
 - (i) please list each instance, who was sanctioned, the breach and the local government involved in the penalties not served; and
- (f) please list what action was taken against each of the local government members who didn't comply with the penalties?

4197. Mr A. Krsticevic to the Minister for Local Government:

I refer to the recent vote of no-confidence in Mayor Colin Dewhurst, which passed 10 to 1 by City of Gosnells councillors, and ask:

- (a) has the department received complaints over Mayor Dewhurst's conduct:
 - (i) if yes, how many complaints;
 - (ii) who lodged the complaints;
 - (iii) on what dates were the complaints received by the department;
 - (iv) how many of the complaints were deemed to be serious; and
 - (v) what action did the department take against each of the complaints;
- (b) considering Mayor Dewhurst hasn't resigned despite a vote of no-confidence, is the Minister considering adding the City of Gosnells to the list of local governments under active investigation by the department:
 - (i) if not, why not; and
- (c) in relation to the review of the *Local Government Act 1995* being undertaken by the department, will future consideration be given to councils who directly elect a Mayor to also have the power to remove a councillor from that office:
 - (i) if not, why not?

4198. Mr A. Krsticevic to the Minister for Local Government:

I refer to the election of mayors throughout WA's local governments, and ask:

- (a) how many different systems are used to elect mayors in WA;
- (b) please list each council and its system for electing mayors; and
- (c) in relation to the current review of the *Local Government Act 1995* will the Minister seek to implement a standard system for the election of mayors:
 - (i) if yes, what is the preferred method?

I refer to media reports that the State Government will not be extending the contract of Art Gallery of WA director Stefano Carboni, and ask:

- (a) when did the State Government advise Mr Carboni his tenure wouldn't be extended;
- (b) was Mr Carboni informed of the State Government's decision by the Minister;
- (c) what were the reasons behind not extending Mr Carboni's contract;
- (d) will Mr Carboni serve the remainder of his existing contract:
 - (i) if yes, when does his existing contract expire; and
- (e) when will the State Government appoint a new director?

I refer to Lotterywest, and ask:

- (a) how much money was distributed in grants by the agency in each of the past five years:
 - (i) can the Premier list the grants, the amounts, the purpose and the bodies that received them in each of the past five years?

4203. Mr A. Krsticevic to the Premier; Minister for Public Sector Management; State Development, Jobs and Trade; Federal-State Relations:

I refer to Lotterywest, and ask:

- (a) what were Lotterywest's management costs as a percentage of total expenditure for each of the past five years?

4204. Mr A. Krsticevic to the Premier; Minister for Public Sector Management; State Development, Jobs and Trade; Federal-State Relations:

- (1) How much has Lotterywest spent on the Retail Transformation Program for each of the past four years:
 - (a) how much was budgeted for the program in each of those years; and
 - (b) did the program deliver all of the outcomes as stated in its original plan:
 - (i) if not, which outcomes weren't delivered and why?

 - (vi) Set For Life;
 - (vii) Scratch'n'Win;
 - (viii) Cash 3;
 - (ix) Soccer Pools; and
 - (x) Super66?

4206. Mr A. Krsticevic to the Minister representing the Minister for Education and Training:

Can the Minister please provide a breakdown on the number of VacSwim and Interm Swimming enrolments for each of the past four years:

- (a) how many overseas-born students attended the swimming lessons; and
- (b) please list which country attendees originated from and the numbers from each country:
 - (i) provide a breakdown of male and female attendees from each country?

4207. Mr A. Krsticevic to the Minister for Citizenship and Multicultural Interests:

I refer to the rise in drownings among overseas-born West Australians and ask has the Office of Multicultural Interests worked with relevant State Government agencies to conduct swimming lessons specifically targeted to these citizens:

- (a) if not, why not;
- (b) if yes, which agencies:
 - (i) how many lessons have been conducted for each of the past four years;

- (h) did the Minister, Ministerial staff, Department staff or public servants attend any of the forums:
 - (i) if yes, who attended, what were the locations and dates of those attendances?

4213. Mr P.A. Katsambanis to the Minister for Tourism; Racing and Gaming; Small Business; Defence Issues; Citizenship and Multicultural Interests:

- (a) what is the total other revenue generated by the Art Gallery of WA for each of the past five years:
 - (i) please list the categories in which the Art Gallery of WA generated the other revenue and the relevant amounts for each of those years?

4218. Mr A. Krsticevic to the Minister for Culture and the Arts:

I refer to the Art Gallery of WA and ask how many volunteers have operated within the agency's venues for each of the past five years, and:

- (a) for each year please list the total amount of hours that have been volunteered?

4219. Mr A. Krsticevic to the Minister for Culture and the Arts:

I refer to the Art Gallery of WA and ask how many FTEs worked at the Art Gallery for each of the past five years and:

- (a) please provide a breakdown of the FTEs in each section of the gallery for each of the years;
- (b) were any FTEs seconded from other State Government agencies:
 - (i) if yes, how many and for how long; and
- (c) how many FTEs accepted redundancies for each of the past five years?

4220. Mr A. Krsticevic to the Minister for Culture and the Arts:

I refer to the Art Gallery of WA and ask what were the payments to board members for each of the past five years and:

- (a) please provide a breakdown of the payments to each board member for each year?

4221. Mr A. Krsticevic to the Minister for Culture and the Arts:

I refer to the Minister's answer to Question on Notice No. 3421 (1)(b) on 14 August 2018 that \$1,425,538.22 including GST was spent on new lighting tracks for the Art Gallery of WA, and ask:

- (a) how does the Minister reconcile that figure with the statement in the Art Gallery of WA 2017-18 annual report that the State Government provided total funding of \$1,000,000 to the project; and
- (b) where did the additional money come from to fund the lighting project:
 - (i) did any of the extra funding come from the State Government's annual appropriation to the Art Gallery of WA; and
 - (ii) if yes, how much money?

4222. Mr A. Krsticevic to the Minister for Culture and the Arts:

I refer to the statement to Assembly Estimates Committee B on 22 May 2018 by the Director General of Local Government, Sport and Cultural Industries Mr Duncan Ord that the department would deliver 7,000 square metres of exhibition space to the new WA Museum, and ask:

- (c) were fees paid to any others for Heritage Council, Development Committee or Register Committee meetings in each of those years?

4227. Mr A. Krsticevic to the Minister for Heritage:

Can the Minister please provide:

- (a) a list of the private owners, their projects and the amounts they received in Heritage Grants assistance for each of the years 2015-16, 2016-17, 2017-18 and 2018-19 and; and
- (b) a list of private owners, their projects and the amounts sought in denied Heritage Grants applications for each of those years:
 - (i) what were the reasons each of the applications were denied; and
 - (ii) were any of the projects granted funding in following years and if yes then which years and how much?

4228. Mr A. Krsticevic to the Minister for Culture and the Arts:

In relation to the State Library of WA can the Minister please provide the number of items sent to refresh public library collections throughout Western Australia, including Indian Ocean Territories for each of the past five years and:

- (a) for each of the years please list the number of new items sent and their cost?

4229. Mr A. Krsticevic to the Minister for Culture and the Arts:

I refer to the State Library of WA 2017-18 Annual Report and ask if any of the library's collections were impacted by the significant drop in the level of controlled conditions at the venue:

- (a) if yes, how many individual items were impacted;
- (b) what was the value of the items impacted;
- (c) how many of the impacted items are unsalvageable:
 - (i) what was the value of the unsalvageable items; and
- (d) have any of the unsalvageable items been replaced:
 - (i) what was the cost to replace the unsalvageable items?

4230. Mr A. Krsticevic to the Minister for Culture and the Arts:

Can the Minister provide for each of the past five years the percentages reached for controlled environment levels at the State Library of WA:

- (a) what were the budgeted percentages for each of the years; and
- (b) why was the percentage in 2017-18 at 85% when the Budget Papers targeted a 98% result?

- (g) please provide a breakdown of the levels of staff for each category for each of the past five years?

4232. Mr A. Krsticevic to the Minister for Culture and the Arts:

I refer to the State Library of WA and ask how much was paid in insurance premiums for directors and officers for each of the past five years?

4233. Mr A. Krsticevic to the Minister for Culture and the Arts:

I refer to the State Library of WA 2017-18 Annual Report and ask of the four recorded instances of unauthorised credit card use what was the total value of the charges:

- (a) please list the value of the individual credit card charges;
- (b) what were the dates of the unauthorised usage; and
- (c) how many staff members were involved in the unauthorised usage?

4234. Mr A. Krsticevic to the Minister for Culture and the Arts:

I refer to the State Library of WA 2017-18 Annual Report and ask why has there been a gradual decline in public library staff attending training and:

- (a) please provide a breakdown of courses provided to public library staff for each of the past five years and how many staff members attended each course; and
- (b) what courses have been cut from the training program over the past four years:
 - (i) why were the courses cut?

4235. Mr A. Krsticevic to the Minister for Culture and the Arts:

I refer to the State Library of WA 2017-18 Annual Report which stated total stock has fallen from 2,808,556 items in 2016-17 to 2,672,002 in 2017-18, and ask:

- (a) what was the value of the reduction in stock items;
- (b) what happened to the cut stock;
- (c) will the cut stock be replaced in future years;
- (d) how many items amongst the cut stock are irreplaceable; and
- (e) what is the total value of stock on hand?

4236. Mr P.A. Katsambanis to the Treasurer; Minister for Finance; Energy; Aboriginal Affairs:

I refer to government agencies and trading enterprises paying small business accounts, and ask:

- (a) in 2017 and as of 1 October 2018, how many times were there instances where government agencies and/or trading enterprises failed to pay small business accounts within 30 days:
