- (1) In Schedule 1 clause 9(2):
  - (a) delete "magistrate " and insert:

magistrate a person who meets the qualification requirement set out in clause 2(2)(a).

- (b) delete paragraphs (a) to (c).
- (2) In Schedule 1 clause 9(3)(a) delete "appointment; but the period must not extend beyond when the appointee reaches 70 years of age; and" and insert:

appointment, which cannot exceed 12 months; and

- (3) After Schedule 1 clause 9(3) insert:
  - (3A) A person appointed under subclause (2) is eligible for reappointment.

New clause agreed to.

Clauses 9 to 11 agreed to.

Title agreed to.

Consideration in detail concluded.

Ordered, That the third reading of the bill be made an Order of the Day for the next sitting of the Assembly.
