Questions listed for this sitting: -

8475. Mr J.N. Hyde to the Minister for Culture and the Arts

I refer to funding for maintenance to Culture and the Arts infrastructure responded to in Question on Notice No. 8130, and I ask:

- (a) will the Minister please provide a list of the 'known high priority works' referred to in the reply, and if not, why not;
- (b) how much is allocated for each work, when will work begin, and when will work be completed; and
- (c) how much has been allocated for the assessments being carried out by the Department of Culture and the Arts and the Department of Finance's Building Management and Works?

8476. Mr P.B. Watson to the Minister for Housing

In relation to the National Rental Affordability Scheme (NRAS) and Yaran Property Group developments at Little Grove:

- (a) can the Minister please provide an explanation as to how and why the Department considers Little Grove to be a priority area of interest under the scheme;
- (b) the Department claims, in relation to the development, that in regional areas it can take a more relaxed view to proximity to services and greater distances to services can be tolerated. Yet there is no provision in the NRAS Act for such a view to be taken. On what basis was such a relaxation exercised and why;
- (c) the Department of Families, Housing, Community Services and Indigenous Affairs website states that typically, NRAS dwellings are indistinguishable from other

middle-market dwellings. Yet these developments are comprised solely of single bedroom units on mainly 200 square metre lots, and are starkly out of character with the surrounding middle-market dwellings of established family housing on a minimum quarter-acre and larger semi-rural blocks. Why does the Department of Housing consider that the Yaran Group proposals are indistinguishable from other middle-market dwellings in Little Grove;

- (d) the Department has stated that the one-bedroom design of these dwellings is suited to retirees. On what basis has it determined that these units are suited to retirees in the absence of public transport, medical services, supermarkets and pharmacies in the Little Grove area:
- (e) the Department has stated that the NRAS does allow for extensions where there are events outside the applicant's control, such as planning delays, and suggests that it will grant a 12-month extension to Yaran's 30 June 2012 development deadline despite the fact that Yaran's original application did not comply with a number of planning codes as well as NRAS eligibility criteria. Why was an extension granted for these developments; and
- (f) Little Grove is over 10 kilometres away from all services except for a primary school and a tourist-oriented convenience store. If there was an application for NRAS funding for a development 10 kilometres outside any other town in the South West would the application be treated as favourably, and if not, then on what basis would it be treated differently, given that the availability of services would be similar?

- (c) has the Minister sought or provided any other heritage advice regarding further changes to the Hummerston building, its storage or future use; and
- (d) will the Minister table that advice, and if not, why not?

- (e) if these homes are to be sold, by what date is this to be done?

- (1) How many Orders have been made by the State Administrative Tribunal (SAT) for the appointment of a guardian for an adult person in the first seven months of 2012?
- (2) How many of the Orders made by the SAT for the appointment of a guardian for an adult person, in the first seven months of 2012, were for a person under the care of a hospital or registered age care facility?

8482. Mr M.P. Murray to the Minister for Sport and Recreation

I refer to speculation about the future of Patersons Stadium in Subiaco and ask:

- (a) what consultation has the Government undertaken in regard to the future of Patersons Stadium;
- (b) has any funding been put aside from the \$700 million Burswood Stadium to undertake consultations, future redevelopment or usage for Patersons Stadium;
- (c) does the Government want to retain Patersons Stadium as a football venue;
- (d) if not, what income stream will the Western Australian Football Commission use to maintain its viability;
- (e) if the West Coast Eagles do not use Patersons Stadium as a base will the Western Australian Football League Clubs be able to negotiate lease arrangements with the Western Australian Football Commission to use Patersons Stadium; and
- (f) does the Government envisage a future for Leederville Oval if co-tenants Subiaco Football Club and East Perth Football Club relocate to Patersons Stadium?

8483. Mr B.S. Wyatt to the Premier

I refer to the Government's intention to sell 5.8 hectares of land to Crown for the purposes of a new hotel, and I ask:

- (a) who provided the Government with the valuation of the land;
- (b) was a written valuation provided to the Government, and if yes:
 - (i) did that valuation specifically take into account that that land needed to be remediated; and
 - (ii) if so, what was the estimated value of the cost to remediate the land;
- (c) the Premier said in Parliament on 9 August 2012 that the valuation was provided from within Government. Which Government departments/agencies provided those valuations; and
 - (i) were they written valuations; and
 - (ii) on what date were the valuations provided to Government;
- (d) specifically, what remediation is required on the land;
- (e) did the Government obtain a written costing of the likely cost to remediate the land, and if so, who provided that costing and when;
- (f) will the Government provide copies of any valuation of the land and the costings for its remediation;
- (g) in Parliament on 9 August 2012, the Premier stated that Burswood still has an entitlement to acquire further land, and I ask:
 - (i) how much further land is Burswood entitled to acquire; and
 - (ii) have any approaches been made by Burswood to the Government to acquire this land, and if so, when were the approaches made and over which land were the approaches made;

- (h) in Parliament on 9 August 2012 the Premier stated that Burswood has an entitlement to purchase an additional 10 hectares, and I ask:
 - (i) from what clause of the Casino (Burswood Island) Agreement Act 1985 does Burswood have an entitlement to acquire an additional 10 hectares of land;
 - (ii) on what date did Burswood officially notify the Government of their intent to exercise their entitlement to purchase an additional 5.8 hectares of land; and
 - (iii) in Burswood's notification of their intent to exercise its entitlement to purchase 5.8 hectares of land, did Burswood have estimations of the value of the land, and if so, what were those estimations;
- (i) what consideration was given to the impact of the Premier's decision to facilitate Crown to place a hotel and associated car parking areas on land sold from the Burswood Golf Course to the residents located on the Peninsula estate immediately to the east and adjoining the proposed site;
- (j) will those residents be afforded an opportunity to have any influence on the size, shape and specific positioning of structures and associated car parking areas on the land immediately to their west; and
- (k) is there an intent to provide monetary compensation to those residents whose property values will be affected?

8484. Mr B.S. Wyatt to the Treasurer

- (1) Is the Government Employees Superannuation Board (GESB) closing down or reducing its financial advice service to members, and if yes:
 - (a) why; and
 - (b) when will the financial advice service be withdrawn?
- (2) Is GESB still taking appointments from members for financial advice, and if no, how many members have had their appointments for financial advice cancelled or referred to another provider?
- (3) Is GESB providing members with alternative financial advisors, and if so, who?
- (4) Can the Treasurer confirm that those members who have paid for financial advice from GESB in the past are entitled to ongoing financial advice at a reduced rate or at no charge?
- (5) How many GESB members have previously paid for financial advice?
