Buti presented a petition from 110 persons requesting that the use of alternate routes for heavy haulage vehicles using Albany Highway between Armadale and Kelmscott be promoted, by installing signage on Tonkin Highway, Albany Highway and Armadale Road (P. 629).

Container Deposit Scheme – Ms L.L. Baker presented a petition from 19 persons requesting that the Legislative Assembly calls upon the Barnett Government to immediately introduce a Western Australian Container Deposit Scheme, similar to the system that operates in South Australia (P. 630)

Moore River Estuary Development – Ms L.L. Baker presented a petition from 56 persons requesting that the Legislative Assembly recommends that the land adjoining the proposed Wilbinga Conservation Park be protected from future development (P. 631).
