In relation to the 94 redundancies planned for the Department of Water over the next two years, will the Minister provide the House with the following details:

- (a) the location (or office) to which each of the positions are attached; and
- (b) the level and title of each position?

- (1) How many Orders have been made by the State Administrative Tribunal (SAT) for the appointment of a guardian for an adult person in the first five months of 2012?

In relation to grants to local government bodies in connection with the issue of local government reform:

- (a) which local government bodies received a grant to compensate them for asset management, long-term financial planning and strategic planning undertaken for structural reform and capacity building;

8270.Mr F.M. Logan to the Minister for Water

I raise the issue of the ageing infrastructure of the Water Corporation's mains and pipes, and ask:

- (a) does the Water Corporation have an on-going maintenance program that identifies the age of water mains and pipes, inspects those pipes internally and externally, and then replaces the most critical; and
 - (i) if so, how does this program work;
- (b) does the Water Corporation have a predictive maintenance program or regime in place for its mains and pipes which calculates those most likely to fail; and
 - (i) if so, how does this program work and how long has it been in place;
- (c) how much money has been spent per annum over the years 2009/2010/2011, and will be spent in the forthcoming budget year, on mains and pipe replacement, and where;
- (d) how many miles/kms of asbestos piping is still being used by the Water Corporation to transport water;
- (e) where is the most significant concentration of asbestos piping in the water system;
- (f) is there a program in place to continually replace asbestos piping; and
 - (i) if so, how much money has been spent on this program over the years 2009/2010/2011, and will be spent in the forthcoming budget year; and
- (g) is there a program of internal inspection on the Perth metropolitan mains piping system, including those that carry dam waters, such as the south west highway main; and
 - (i) if so, please provide an overview of the system and the dates on which the mains pipes have been internally inspected?

8271.Mr C.J. Tallentire to the Minister for Health

I refer to the proposal for a medical school to be located at Curtin University, and ask:

- (a) what studies have been done into the availability of preregistration hospital placement opportunities for newly graduated doctors;
- (b) what are the Government's plans to cope with the already known increase that will take place in the number of graduating doctors from the University of Western Australia and Notre Dame; and
- (c) has the proposal factored in the possibility that the number of graduates may exceed the number of placement opportunities?

I refer to the proposed Peel Water Reuse Scheme promoted by local governments in the Peel Region, and I ask:

- (a) has the Water Corporation been involved in, or with, this proposal; and
 - (i) if so, how does it support the project;

- (c) the Peel Development Commission (PDC) claims that a team of government departments and agencies has been working closely with Alcoa to develop a regional water reuse scheme. If Alcoa is seeking climate independent water as suggested, why didn't PDC and the government agencies direct Alcoa to negotiate directly with the Water Corporation;

- (d) how much water is to be supplied by the Gordon Road Wastewater Treatment Plant reuse project; and
 - (i) how much will be used by Alcoa; and
 - (ii) how much by other users;
- (e) given the Water Corporation's 'Water for the Future' policy directions, why is this Agency not providing this water to Alcoa or any regional user as part of its normal business practice; and
- (f) PDC claims that the Water Infrastructure Group, which is made up of local councils and industry players, has selected a preferred private sector operator of this project. Was this selection put out to tender; and
 - (i) if not, why not?

- (b) did this property enjoy a refurbishment within the last 3 years; and
 - (i) if so, when, what work was done, and at what cost;

- (c) when did the tenancy at this property expire;
- (d) on what date was this property demolished;
- (e) was anything salvaged from this property prior to its demolition, and;
 - (i) if yes, what was salvaged;
- (f) how many properties will be constructed on this site;
- (g) when is construction due to commence, and when is it expected to be completed; and
- (h) will the properties remain Homeswest properties or will they be transferred to Community housing?

I refer to the placement of transportable dwellings in Duke Street, Northam, and I ask:

- (a) who was awarded the contract for establishing the transportable dwellings at this site;

- (d) what services did this contract provide for;
- (e) how much has been spent on these dwellings to date;
- (f) how much is estimated to be spent to bring them up to a standard at which they can be occupied;
- (g) on what date were the dwellings transported to this site;
- (h) when were the dwellings originally due to be completed, and what is the new completion date;
- (i) why has it taken so long to bring these dwellings to a point at which they can be tenanted;
- (j) was the local community or Council consulted about the use of transportable dwellings at this site; and
 - (i) if not, why not; and
- (k) how many people will these dwellings be able to house?
