1. Meeting of Assembly

The Assembly met at 9.00 a.m. pursuant to adjournment.

The Speaker took the Chair.

2. Petitions

Electronic Speed Zone Signs – Mr P.B. Watson presented a petition from 16 persons requesting that the Legislative Assembly call upon the Minister for Transport to make Albany Primary School and Mount Lockyer Primary School priority locations for the 2011–2012 installation program for electronic speed zone signs (P. 512).

Protection from Second Hand Smoke – Mr P.B. Watson presented a petition from 26 persons requesting that the Legislative Assembly enact laws to further protect people from exposure to second hand tobacco smoke in public places. (P. 513).

Container Deposit Scheme – Mr P.B. Watson presented a petition from 31 persons requesting that Legislative Assembly call upon the Barnett Government to immediately introduce a Western Australian Container Deposit Scheme, similar to the system that operates in South Australia (P. 514).

Skilled Local Jobs – Mr P.B. Watson presented a petition from 134 persons requesting that the Western Australian Parliament pass laws that would ensure a greater share of skilled work for major resource projects is performed in Western Australia (P. 515).

- (b) Did you inform anyone that prescribed burns should not have been undertaken on or in advance of hot windy days?
- (c) When were you first told that the prescribed burns in Margaret River had broken containment lines?

- (d) Did the Department of Environment and Conservation communicate with Fire and Emergency Services Authority in regards to the prescribed burn?
- (e) When were the Incident and Deputy Incident controller appointed?
- (f) At what point was Mr Gregson first informed by DEC that the fire had breached containment lines and was out of control?
- (g) When did FESA take over control of the incident?

Debate ensued.

- f) At what point was Mr Gregson first informed by DEC that the fire had breached containment lines and was out of control?
- g) When did FESA take over control of the incident?
