I hereby resign from the Parliament of Western Australia as Member of the Legislative Assembly seat of Willagee in accordance with Section 25 of the Constitution Acts Amendment Act 1899.

That the seat for the electoral district of Willagee be and is hereby declared vacant by reason of the resignation of Alan John Carpenter.
