THE PARLIAMENT of Western Australia begun and held in the City of Perth on Thursday, the Twenty-ninth day of April in the Seventieth year of the Reign of Her Majesty Queen Elizabeth II, and in the Year of Our Lord, Two thousand and twenty-one.

4. Time for holding the first session of the Legislative Council in the 41st Parliament Thursday 29 April 2021 at 2.45 pm is fixed as the time for holding the first sitting of the first session of the Legislative Council in the 41st Parliament.

Mrs M.H. Roberts then reassumed the Chair as Speaker.
