1. Meeting of Assembly

5. Health Practitioner Regulation National Law (WA) Amendment Bill 2017

The Minister for Health, pursuant to notice, moved,

That a bill for "An Act to amend the *Health Practitioner Regulation National Law (WA) Act 2010* and to make consequential amendments to other Acts." be introduced and read a first time. Question put and passed.

- amend the *Criminal Property Confiscation Act 2000* in relation to the role of the Corruption and Crime Commission." be introduced and read a first time.

Question put and passed.

The Attorney General presented an explanatory memorandum and bill read a first time.

The Attorney General moved, That the bill be now read a second time.

Mr P.A. Katsambanis moved, That the debate be adjourned.

13. Testing at Public Health Facilities

Dr M.D. Nahan, pursuant to notice, moved,

That this House calls on the McGowan Government, in the interests of public health and providing surety to the community, to immediately identify and begin testing across Western Australia for all thermostatic mixing valves installed at public facilities, similar to those installed at Perth Children's Hospital, and to conduct thorough visual and chemical testing of the Queen Elizabeth II Medical Centre ring main to rule it out as a source of lead.

Debate ensued.

Debate interrupted by the Chair (Minister for Health speaking) and adjourned until a later stage of the sitting.
