- (m) Given the lack of success in securing an independent private operator to date, why won't the Minister commit the State Government to continue managing and operating the venue for another five years in order to provide some stability to the users/stakeholders?

**5051. Mr J.E. McGrath to the Minister for Tourism:**

I refer to the article on page 4 of The West Australian on 28 March 2019 which stated, "The WA Government had a contract with Tennis Australia and the International Tennis Federation to stage the Hopman Cup through to 2022, but the contract was able to be amended if all parties agreed", and I ask:

- (a) Can the Minister confirm that the amendments were made to the contract agreed to under the former Barnett Government, in which the Government exercised a contract option in 2017 to secure the Hopman Cup in Perth through to 2022;
- (b) If yes to (a), what were the amendments to the contract agreed by the State Government, Tennis Australia and the International Tennis Federation;
- (c) As the Hopman Cup is one of Perth's most successful home-grown sporting events, can the State Government demonstrate how it has acted in the interests of tennis professionals and the people of Western Australia in not preserving the event's future here in Perth;
- (d) Did the State Government ever consider that the ATP Cup and the Hopman Cup could co-exist;
- (e) If no to (d), why not;
- (f) Was the possibility of hosting the Hopman Cup in Perth in the week prior to the ATP Cup (or at a different time of the year) ever considered by the State Government;
- (g) If no to (f), why not; and

- (h) Given that the New South Wales Government has secured the finals of the ATP Cup until 2022, what efforts will the State Government make to secure the finals of the event in future years in Perth?
