#### 1. BACKGROUND

This is the ninth report since the political finance legislation came into force in Western Australia on 9 November 1996. Under the provisions of Part VI of the *Electoral Act 1907*, all political parties, associated entities, individual candidates, Legislative Council groups and other persons are required to provide the Electoral Commissioner with details of gifts and/or income received and expenditure incurred for electoral or political purposes.

This report relates to the operation of Part VI of the Act over the 2004–2005 financial year. It provides information on the annual returns lodged by political parties and associated entities for this period, in addition to election returns submitted for the 2005 State general election.

The 2004–2005 Political Finance Disclosure Schedule, which highlights key disclosure dates during the period, as included in Appendix 1.

#### 1.1 Essential Features of the Political Finance Legislation

#### **Agents**

All political parties must appoint an agent for disclosure purposes. Party agents, who must register with the Electoral Commissioner, assume responsibility for lodging disclosure returns on an ongoing basis. At an election, candidates and non-party groups may appoint an agent to act for them or accept responsibility for compliance with the Act themselves. A separate agent appointment is required for each election for both candidates and non-party groups. Appointments must be made before 6.00 pm on the day before polling day in the election.

The financial controller of an associated entity is considered to be its agent.

#### Gifts

Gifts of \$1,600 or more must include the name and address of the person who made the gift. In accordance with regulation 3 of the *Electoral (Political Finance) Regulations 1996*, the current specified amount of \$1,600 was reviewed after the 2005 State general election and increased to \$1,800. This took effect as from 1 July 2005 and will effect the 1 July 2005 to 30 June 2006 disclosure returns. Acceptance of donations from unidentified persons or sources equal to or more than the specified amount is prohibited under the Act. Under section 175R(5) of the Act, anonymous donations above the specified amount are payable to, or may be recoverable by, the State.

#### **Annual Returns**

All political parties (whether registered or not) and their associated entities are required to lodge an annual (financial year) return by 30 November, disclosing all gifts and other income received for the previous financial year.

#### **Election-related Returns**

After an election, all parties, candidates, Legislative Council groups and other persons are required to send an election return to the Electoral Commissioner within 15 weeks after polling day.

Political parties are required to disclose only electoral expenditure incurred for an election, as they disclose all gifts and other income in their annual returns. Associated entities are not required to disclose electoral expenditure incurred for an election.

Candidates are required to disclose all gifts received and electoral expenditure incurred during the disclosure period for the election, which ends 30 days after the current election and:

- if the candidate was a candidate in a previous election (in the last five years), it commences 30 days after polling day in the previous election in which they were a candidate; and
- for new and other candidates, it commences one year before the day of nomination in the present election.

Legislative Council groups must submit a return disclosing all gifts received and expenditure incurred between the hour of nomination and 30 days after the current election.

Persons other than political parties, associated entities, candidates and groups who incur expenditure for political purposes must disclose all gifts received from 30 days after polling day in the last preceding general election to 30 days after the current election. Relevant details of gifts that are expended partially or wholly for political purposes must be provided if the gift equals or exceeds the specified amount threshold of \$1,600. In addition, if the total amount of electoral expenditure exceeds \$500, a return is required to be completed disclosing that expenditure. Other persons may include interest groups, lobby groups, welfare groups, unions and associations.

#### 1.2 Records to be Kept

Under the *Electoral (Political Finance) Regulations 1996*, agents of political parties, candidates and groups must maintain:

- a receipt book, for recording details of money received;
- an acknowledgment book, for recording details of gifts other than money received;
- bank and financial institution statements; and
- an expenditure book.

The financial controller of an associated entity must keep all of the above except for an expenditure book.

Other people who incur expenditure for political purposes must keep a record of all gifts received for political purposes and maintain:

- a receipt book;
- an acknowledgment book; and
- bank and financial institution statements.

People who incur electoral expenditure must also maintain:

- an expenditure book; and
- bank and financial institution statements.

All records and bank and financial institution statements must be retained for six years.

According to regulation 11 of the *Electoral (Political Finance) Regulations 1996*, the agent of a political party may apply to the Electoral Commissioner for approval for the party to keep or cause to be kept a system of accounting records other than those prescribed in the legislation. If this application is approved by the Electoral Commissioner, the party must keep these records in accordance with this agreement.

#### 1.3 Role of the Western Australian Electoral Commissioner

The Electoral Commissioner is responsible for maintaining a register of political party agents and obtaining the relevant information from parties, associated entities, candidates, groups and other persons through annual and election-related disclosure returns. The Commissioner is empowered to

check all returns, obtain any information relevant to disclosure requirements, and to interview people and scrutinise bank or other financial accounts where donations may be deposited.

The Electoral Commissioner also prepares an annual report (this report) on the operation of Part VI of the *Electoral Act 1907* in relation to the previous financial year. This is submitted to the Minister for Electoral Affairs, who tables the report in Parliament.

#### 2004–2005 ANNUAL RETURNS

Agents of the various political parties were sent letters in April and September 2005, reminding them that the disclosure period for the 2004–2005 annual returns ended on 30 June 2005 and that returns were due to be lodged with the Commission by 1 December 2005. A total of 21 political parties and four associated entities lodged disclosure returns for the period. This compares with 12 political parties and three associated entities lodging disclosure returns for the 2003–2004 financial period. Data provided in the 2004–2005 returns are included as Appendices 2, 3, 8 and 9 of this report.

#### 3. 2005 STATE ELECTION RETURNS

#### **Parties**

During the election period, political parties received copies of the relevant forms and the *Disclosure of Gifts, other income and electoral expenditure Guidelines* explaining their financial disclosure requirements. Data provided in their returns, relating to electoral expenditure incurred in an election, as included in Appendix 2.

Associated entities are not required to disclose expenditure incurred in an election.

#### Candidates, Groups and Other Persons

Candidates and groups were provided with a copy of the *Disclosure of Gifts, other income and electoral expenditure* (candidates and groups) *Guidelines* and copies of the relevant forms as part of the nomination process prior to the 2005 State general election. Information regarding financial disclosure was also included in *A Guide for Candidates* which was prepared for Legislative Assembly and Legislative Council candidates. Booklets and relevant forms were handed out to the party secretary or agent of the 14 registered parties for distribution to party candidates and groups. Candidates and groups who were not from the registered parties received the information packs and forms upon nomination.

The disclosure period for candidates, groups and other persons ended 30 days after polling day, which was 28 March 2005. The following number of candidates appointed agents by the deadline of 25 February 2005 to lodge a disclosure return for them: 242 candidates out of 375 for the Legislative Assembly and 123 candidates out of 185 for the Legislative Council.

Election returns were due within 15 weeks of polling day, which was by 13 June 2005. As at 30 June 2005, 91 of the 375 Legislative Assembly candidate returns and 117 of the 185 Legislative Council candidate returns remained outstanding.

As at 25 August 2006, all but one return had been received. In accordance with sections 175U(1) and 205 of the *Electoral Act* 1907, prosecution action has begun against the candidate who has not submitted an election return.

Data provided in the above returns is included as Appendices 4, 5, 6, 7, 10, and 11 of this report.

#### 4. AUDIT OF RETURNS

The Act provides for the Electoral Commissioner to authorise officers to investigate returns required under Part VI. In order to avoid duplication of effort, a coordinated audit approach was again arranged with the Australian Electoral Commission (AEC), as political parties required to lodge Commonwealth returns may lodge those same returns to comply with the requirements of the *Electoral Act 1907*. The AEC audited the 2004–2005 Commonwealth annual disclosure returns of six Western Australian based parties and two associated entities who prepared Commonwealth returns, to check their compliance with the disclosure provisions of the *Commonwealth Electoral Act 1918*.

The Commission also employed an independent auditing firm Stanton Partners to audit the annual returns of the registered political parties not audited by the AEC. The audit results indicated a high level of compliance with the requirements of the Act and Regulations and no instances of deliberate misrepresentation were found.

The Commission also employed the auditors, to audit the election returns from a selection of Legislative Assembly and Legislative Council candidates, political parties, associated entities, groups and other persons. One of the Commissioner's staff and the principal auditor made the selection on the basis of getting an appropriate spread from each category. For example, from the 560 candidates who contested

Assembly and Council vacancies, a sample of 80 candidates was selected: 35 from the Legislative Assembly and 45 from the Legislative Council. This sample included candidates from each registered political party, independents, those with high income and/or expenditure amounts and candidates submitting nil returns. In addition, six political parties, 17 Legislative Council groups and two other persons were audited.

Audits conducted on behalf of the Electoral Commissioner found no instances of deliberate misrepresentation. The audits did reveal several instances of errors of omission or issues requiring clarification, including wrong categorisation of electoral expenditure. The individuals and parties concerned will be informed and asked to submit amended returns.

Some candidates did not maintain adequate records as required by regulation 15 of the *Electoral* (Political Finance) *Regulations 1996*, which resulted in a lack of records to audit. For future elections all candidates will be reminded of the necessity to maintain the relevant records in accordance with the *Electoral* (Political Finance) *Regulations 1996*.

#### 5. ACCESS TO RETURNS

The Western Australian Electoral Commission maintains copies of each political finance return. In accordance with section 175ZC of the Act, members of the public may view or obtain copies of returns, which are available four weeks after the end of the lodgement period. State election–related returns were made available to the public on 13 July 2005. Annual returns for the 2004–2005 financial year were made available on 29 December 2005. Annual returns of political parties and associated entities lodging a Commonwealth return with the Western Australian Electoral Commission can be viewed on the Australian Electoral Commission's web site at <a href="https://www.aec.gov.au">www.aec.gov.au</a>.

#### 6. SECTION 175ZE OF THE ELECTORAL ACT 1907

Public agencies who are required to publish an annual report under the *Financial Administration and Audit Act 1985* or any other written law must include a statement in the report of all expenditure incurred by or on behalf of the public agency during the reporting period in relation to:

- advertising agencies;
- market research organisations;
- polling organisations;
- direct mail organisations; and
- media advertising organisations.

This statement must detail the total amount of the expenditure, the amount of expenditure for each heading listed above, and the name of each person, agency or organisation to which an amount was paid. No details are required if the amount of expenditure under a heading is less than \$1,600, although a 'Nil' statement is still required to be published.

#### 7. PUBLICATIONS

The Commission has produced *Disclosure of Gifts, other income and electoral expenditure for political parties and entities Guidelines* and *Disclosure of Gifts, other income and electoral expenditure (candidates and groups) Guidelines.* These guidelines outline the purpose of the political finance legislation and the implications for persons involved in the electoral process. A copy of the guidelines is given to candidates and groups at the time of nomination and also sent out to relevant persons at the end of each disclosure period together with a copy of the appropriate disclosure return(s). Commencement of Disclosure Period for Annual Returns

1 July 2004

Commencement of the disclosure period for political parties and associated entities (gifts and other income).

**Election Day**

Date of the 2005 State general election.

End of Disclosure Period for Election Returns

Commencement of Next Disclosure Period 28 March 2005

Being 30 days after election day. The disclosure period for election returns concluded on this day.

The disclosure period for candidates in the 2005 State general election who contest the next State general election or intervening by-elections commences after this day.

**Election Returns Due** 

13 June 2005

Election returns for political parties (expenditure only), candidates, groups and 'other persons' (gifts and expenditure) are due on this day being 15 weeks after Election day.

**Election Returns Publicly Available** 

13 July 2005

Disclosure returns from candidates, groups and 'other persons' as well as expenditure returns by political parties are made available to the public.

End of Disclosure Period for Annual Returns

30 June 2005

End of the annual disclosure period for political parties and associated entities.

**Annual Returns Due** 


30 November 2005

Annual Returns Publicly Available

**29 December 2005** 

Annual disclosure returns for political parties and associated entities are made publicly available from this day.
