### **THE ARCHITECTS ACT 2004**

The Architects Act 2004 became a reality via proclamation on 15 November 2005.

This report is prepared for submission to the Minister for Housing and Works in accordance with the provisions of Section 28 of The Architects Act 2004.

### (1) STATE OF THE REGISTER OF ARCHITECTS

#### (a) Natural Persons

The Register commenced as follows:

# (7) CONTRAVENTIONS OF THE ACT AND COMPLAINTS

# (a) Contraventions of the Act 1 January 2005 to 30 June 2006

In 2005 fourteen (14) letters were issued in respect of the Act advising of the option to prosecute, where non-architects held themselves out as architects.

Until 30 June 2006 three (3) letters were issued in respect of the Act advising of the option to prosecute, where non-architects held themselves out as architects.

One matter from 2005 is ongoing with the parties involved in legal proceedings. All other matters from 2005 until 30 June 2006 were resolved to the satisfaction of the Board.

## (b) Complaints Against Architects - 2005

The Board received four (4) complaints in 2005 alleging misconduct by an architect.

In one case it was decided the architects had no case to answer. In one case legal proceedings were instigated by the complainant and the case with the Board was placed on hold. The Board referred one matter to State Administrative Tribunal and it was conciliated to a mutually agreed outcome. This matter involved legal costs, which were only partially able to be recovered. One case was lodged, withdrawn and then re-lodged. This case is ongoing in 2006.

One matter from 2004 has been finalised with the Board being awarded and accepting the negotiated amount for costs in September 2005.

### (c) Complaints Against Architects - 2006

Until 30 June 2006 the Board has received three (3) new complaints alleging misconduct by an architect. In two cases it was decided that there was no case to answer and the third matter is still under review.

In the one ongoing case from 2005 the Board did not approve of the conduct and instigated a conciliation process between the parties to assist in resolving the matter with the conciliation organised for 21 July 2006. Subsequent to the end of June 2006 this matter has been finalised with the parties reaching a settlement and executing a confidential Deed of Settlement, which included an element of re-education. This case has taken up a large amount of time and Board resources.

### (8) **GENERAL**

#### (a) State Legislation

The Architects Act 2004 was proclaimed in November 2005.

The State Administrative Tribunal (SAT) provisions with new procedures for disciplinary action are now in operation.

What this means is that any complaints against architects must firstly be taken to the Architects Board of WA. The Board determines if there is cause for disciplinary action or not. If the Board believes there is cause for action, the Board, may institute a conciliation process between the parties or refer the complaint/matter to SAT for hearing and determination. SAT will determine the matter and hand down any action against the architect.

If the Architects Board of WA believes there is no cause for disciplinary action, the complainant will be notified and the matter will not be referred to SAT. If the complainant is not satisfied with that decision he/she may appeal to SAT for a review of the decision.

Individuals are not able to take a complaint against an architect direct to SAT. They must approach the Board first. They may go direct to SAT with a complaint against a decision of the Board and SAT will review that decision.

The new Act has meant a lot of changes to the way we conduct our business and our relationship with our clients and the public in general. The Regulations to the new Act are still being refined with the Board seeking legal advice to ensure the inclusion by regulation of the joint AACA/RAIA Code of Conduct.

Greater consumer representation on the Board has ensured a greater level of protection to the consumers of architectural services. One of the stated objectives of the new Act is to "protect the consumers of architectural and related services in Western Australia". This, of course, is a two edged sword as the new Act gives greater powers to the Board when pursuing Offences under the Act by those non-registered people holding out as being an Architect or offering architectural services.

Mandatory continuing education and professional indemnity insurance will be a part of the requirements for ongoing registration if you are offering your services to the public. This will also include employees and academics doing private jobs outside of work hours unless such work is expressly covered under their employers PI Insurance policy.

### (b) Board Award

It is an honour to announce that the Architects Board Award for the year 2006 was awarded to Mr Warren Kerr. Mr Kerr was presented with his award by the Minister, the Hon. Michelle Roberts, at a function held at Lamonts Restaurant in East Perth.

### (c) **Procedural Matters**

The Board and more particularly the Registrar deal on a regular basis with procedural matters mainly relating to:

- Contraventions of the Act most usually non-architects holding out
- Participation with R.A.I.A. on a dual functioning Education Committee.
- Schools visiting panels and annual visiting committees
- Applications for registration
- AACA Professional Practice Examinations
- Inquiries from the public regarding possible misconduct by architects.

The Boards role under the new Act has expanded considerably and there will be many more new procedural matters to be dealt with on an ongoing basis. The year ahead for the Board looks set to be a busy one particularly as we are seeking amendments to the regulations for the new Act.

I would like to thank all Board Members for the work they do and the time they donate and I especially wish to thank the Registrar, Mary-Eileen Scanlan and Assistants Regina Chuah and Veronica Candy, who continue to look after the nuts and bolts and make certain "it all gets done" in an efficient and pleasant manner.
