

#### IMPREST REPORT - MELBOURNE, NOVEMBER 2008

I refer to my requested funds from the Imprest System for Members of Parliament Travel that I used to visit Melbourne during November 2008.

As required under the Imprest System guidelines I hereby provide my written report.

The primary purpose of my trip to Melbourne was to meet with Treasury officials and members of the private sector to discuss the history, strengths, weaknesses and future of 'Public Private Partnerships' (PPPs).

PPPs are a procurement method used by Governments across Australia, including Western Australia, and Internationally, to fund and provide public infrastructure. This is an area that has direct relevance to my portfolio responsibilities as Shadow Treasurer.

Whilst in Melbourne I met with representatives from Deloitte and PriceWaterhouseCoopers. 

#### VISIT TO BELGIUM, SWEDEN AND THE UNITED KINGDOM 4/16 OCTOBER 2008

On Saturday 4th October 2008 I flew to Belgium.

#### BRUSSELS, BELGIUM

#### Monday 6 October 2008

Met with GUNILLA EKBERG, a human rights lawyer working in Brussels. Ms Ekberg is Co-Executive Director of the International Coalition Against Trafficking of Women, and a former advisor to the Swedish Government on human trafficking and violence against women.

Currently her main work is with organisations against trafficking of women.

This meeting was in the context of the Western Australian Government's commitment to repeal prostitution legislation.

In 1998 the Swedish Government decided to curb the proliferation of prostitution and the exploitation of women and children by criminalising the person who hires another for sexual purposes (in other words the purchaser).

Now, ten years later, they have achieved astonishing improvements in each of the following five areas:

Proliferation of prostitution and abuse of women: In 1999 there were 2500 prostituted Swedish women. In 2002 there were 1500 prostituted women. In 2008 recruitment of Swedish women has almost come to a halt.

- c. Invite a critical group of people (including men) to inform them of the issues surrounding prostitution and trafficking and suggest forming a "Justice" group.
- d. Share the information with as many community groups as possible.
- e. Check the status of the current situation governing prostitution in Western Australia.
- f. Look at the Swedish model.

Swedish Prostitution legislation enacted in 1999 was discussed in detail, such as how the legislation came about. The change in public attitudes was driven mainly by women's groups and women Members of the Swedish Parliament.

How it now works – to purchase a sexual service is considered a <u>CRIME</u>.

#### **Enforcement**

Initially the Swedish Government provided three million euros to train the Police force in the prevention of the crime of prostitution (just as they would to curb bank robberies, house break ins, murder, domestic violence etc) and finding the buyers of sexual services.

Ms Ekberg provided information on the special internet unit in the Swedish Police force.

She also explained that Scottish legislation is similar to Sweden (Safe City program). In Norway all parties agreed that they would copy the Swedish model and a vote was taken on October 14<sup>th</sup> 2008 in the Norwegian Parliament which resulted in the passing of similar laws to Sweden.

Strategies were suggested to research trafficking on a state and national level.

Examples of indigenous attitudes towards prostitution in the U.S.A. and Canada were given. American and Canadian Indian women have adopted an official stance on this issue, i.e. Prostitution furthers racism.

#### Tuesday 7 October 2008

MEETING with KASJA WAHLBERG - NATIONAL RAPPORTEUR, SWEDEN

At a meeting of European ministers in the Hague, it was recommended that each country have a National Rapporteur.

Kasja has this post in Sweden, she is a senior police officer overseeing criminal surveillance and trafficking of humans and drugs throughout Sweden. She is also the Swedish representative on The European Commission Expert Group on Trafficking of Human Beings.

She reports via the National Police Board to the government. She is totally independent and may criticise the government, the police service etc.

She began ten years ago when many people did not understand much about the trafficking of humans or prostitution. When cross-border visas were abolished, immigrants from Lithuania (1997) started coming into prostitution. Prior to that there were very few pimps – most Swedish women in prostitution did not have pimps – they operated on their own.

1999 - Sweden introduced legislation to charge buyers of sex.

In the 1970s to 1990 – much research into abused women was undertaken. They found that approximately 70 per cent of women in prostitution are abused and exploited.

Who are the women who end up in prostitution in Sweden? – the answer lies in the common background of these women – sexual abuse and exploitation. It is not the poor girl making a choice to have good clothes etc. Many are so young they do not understand the effects on them later. Kasja interviews many women after they have left prostitution.

Swedish police target pimps, buyers and traffickers. Some of the operational techniques include:

Wire tapping eg. apartments following tip-offs from neighbours.

Children have input into setting up rooms. This facility was near a park and strong emphasis is placed on children spending a lot of time outdoors.

Charges are government subsidised and parent co-contribution is based on income.

Child abuse was briefly discussed, as was a local and specialised centre for autistic children. There are five centres in each district of Stockholm and each have five staff and two special paedagogues to direct staff and assist children with disabilities.

#### Monday 13 October 2009

Met with Sir Al Aynsley Green, United Kingdom's Children's Commissioner.

Received an update from Sir Al Aynsley Green on his role and responsibilities. I hosted Sir Al on his visit to Western Australia in December 2007.

Sir Al will be retiring in 2010. He will undertake an enquiry into the pre-custodial treatment of children before he retires.

We discussed common phenomena relating to the position of Children's Commissioner, including the United Kingdom, Sweden and Denmark. They seem to be universally unpopular and this is mainly because they expose serious issues about children.

Sir Al recommended reviewing the Paris Principles in relation to the operation of the Committee in the Western Australian Parliament.

Also recommended that the United Nations Convention on the Rights of the Child be reviewed in relation to current State and Federal policies. This Convention is reviewed every five years and this was carried out in Geneva in 2008.

Re: Study tour

I hereby report on my recent study tour involving the use of uranium, to increase my knowledge for the time when uranium mining commences in my electorate as per your government's policy.

The first stop was Singapore where I received a briefing from BHP-Billiton's uranium division on the likely trends for the use of uranium in the nuclear energy cycle. My confidence in the short and long-term future of uranium was enhanced.

In London I met Dr Mel Draper, the head of non-proliferation with the British government's Department of Energy and Climate Change.

The briefing in Whitehall was also attended by senior officials from the Foreign Office, British security and public health.

Their advice on their work was invaluable and gave me confidence in what the world is doing to track uranium and ensure it is only used for peaceful purposes.

The briefing was followed by a visit to Urenco's uranium enrichment plant at Capenhurst. This impressive plant, which has been operating with the current centrifuge system since 1982, converts the uranium, which hopefully will be coming from new mines in my electorate, into a range of enrichment, usually from 4 to 5 percent, for use in nuclear power stations.

The next stop in my study tour was to the Sizewell B nuclear power station. The nearby Sizewell A site is in the process of being decommissioned but the British Energy officials I spoke to expect another nuclear power station to be built next to Sizewell B.

### Brief Summary Meetings Held At The Texas House of Representatives

13th - 21st January, 2009

#### Tuesday 13th January

State Representative Harvey Hilderbran and State Senator Troy Fraser

I met with both men separately and discussed my purpose for the trip to the Capitol and then asked them to outline their responsibilities to their Constituents, to the State and to the Covernor.

#### Wednesday, January 14th

Texas Department of Public Safety - ROAD SAFETY

Met with officers from TDPS and they outlined the different responsibilities of State Commissioner, Deputy Commissioner, Lieutenants, Sheriffs, Constables, and State Troopers. Discussed their policy on road safety in regards to speed, education, age requirements for licenses and their training. Discussed whether or not speed was the biggest issue, they said no, by far it was alcohol and youthful recklessness. Discussed the toll on officers families.

#### Texas Department of Criminal Justice - CORRECTIVE SERVICES

We discussed the number of prison location, their grades/level and functions. Training of officers and their 'turn around' and protection. Discussed the toll on the families of Officers.

#### Thursday, January 15th

Texas Commission on Environment Quality - ENVIRONMENT

We discussed Air Quality Planning and attainment of the standard required. Discussed Texas Air Pollution levels and their State Implementation Plan to monitor the levels. Discussed at length their Modeling and Analyzing Air Data Programme. Spoke about their Grants & Incentives Support Implementation to reduce NOx emissions in nonattainment and near-nonattainment areas. They shared about their "...AIR CHECK TEXAS Driver a Clean Machine..." campaign.

Texas Water Development Board - ENVIRONMENT

We discussed at great length the proposal of piping water from East Texas to the water deprived and barren West Texas. They asked for information around the proposal to pipe water from the Kimberley's down to Perth and felt it was still a good idea to float. We discussed aquifers and their uses, also the rights to the fresh water aquifers by landowners. We also discussed the several large desalination plants in Texas, their capacity, primary uses and financial return to the State.

#### Tuesday, January 20th

#### Special Interest Roundtable

Several representatives from the House & Senate came and asked me various questions on Australia and Western Australia. There were no 'questionable' questions asked as they were fairly general. I think I asked more questions to them than they asked me. I mainly asked about their responsibilities in Government and around the Texas Capitol. We discussed the history of the Capitol and Texas relationship to the Federal Union of the United States.

#### Wednesday, January 21st

#### Key Legislative & Committee Staff Roundtable

Met with several staff members of the Texas Legislature and Capitol Committee. Was briefed on their roles and responsibilities. Discussed the 'confidential' aspects of their committee work, of which there were none as all meetings are public! Discussed the procedure of Bills being passed in the Legislature going to the Senate and then returning to the Legislature to become Law. With great interest, we discussed the role of more than 600 lobbyists in the Capitol and their effectiveness.
