

1. Citation

This order is the *Port Authorities (Description of Port of Dampier) Order 2011.*

2. Commencement

This order come into operation as follows —

- (a) clauses 1 and 2 on the day on which this order is published in the *Gazette*;
- (b) the rest of the order on the day after that day.

3. Port of Dampier

(1) In subclause (2) —

Deposited Plan 48590 means Deposited Plan 48590 held by the Western Australian Land Information Authority under the *Land Information Authority Act 2006*.

- (2) The Port of Dampier consists of
 - (a) the seabed in the shaded area shown on Deposited Plan 48590 Sheet 1; and

- (b) the waters in the shaded area shown on Deposited Plan 48590 Sheet 2; and
- (c) the land in the shaded area shown on Deposited Plan 48590 Sheet 3; and
- (d) the area, called the Ashburton Port Area, described in words and shown hatched on Plan 1396 03 07 held by the department principally assisting the Minister in the administration of the *Port Authorities Act 1999*.

4. Order revoked
