### Chair's Foreword

his is the second annual report of the Education and Health Standing Committee in the 41st Parliament. Over the past 12 months the EHSC has worked solidly, with much of our effort focussed on the inquiry into the response of Western Australian schools to climate change, culminating in our report 'Making Hope Practical'. More recently our attention has shifted to the inquiry into the Esther Foundation and unregulated private health facilities.

## **Chapter 1**

### **Committee Activities**

#### Introduction

- 1.1 This report covers the work undertaken by the Education and Health Standing Committee of the 41st Parliament during the 2021-22 financial year.
- During the course of this reporting period (Table 1.1), the Committee:
  - · conducted the inquiry into the response of Western Australian schools to climate change
  - · began the inquiry into the Esther Foundation and unregulated private health facilities
  - held 22 deliberative meetings
  - took evidence from 51 witnesses at 16 public hearings, and held two closed hearings
  - met with 19 people at five briefings, including three school site visits
  - tabled two reports.

#### **Briefings**

- 1.5 In addition to the formal hearings, the Committee held a number of briefings and site visits (Table 1.3).
- 1.6 The Committee visited three metropolitan schools to gather information in relation to the inquiry into the response of Western Australian schools to climate change. These schools were identified as engaging in a high level of sustainability activity and adopting a whole-school approach to sustainability.
- 1.7 The Committee also held two briefings in relation to the inquiry into the Esther Foundation and unregulated private health facilities. One was with a registered psychologist who advised the Committee on using a trauma-informed approach in conducting the inquiry. The other was with representatives from the Department of Health and the Mental Health Commission to gain an early understanding of the existing legislative and regulatory frameworks relevant to the inquiry.

#### **Conferences**

1.8 From 28 to 30 September 2021, the Committee secretariat attended the Australian Association for Environmental Education (AAEE) Biennial Conference 2021, Mandjoogoordap: Changing Tides, in Mandurah. This provided an opportunity to promote the inquiry into the response of Western Australian schools to climate change amongst conference delegates, identify key stakeholders and attend conference sessions relevant to the inquiry.

1.9 Mrs Lisa Munday MLA, Member for Dawesville, also delivered an opening address at the conference on behalf of the Minister for Environment and Climate Action.

#### **Reports Tabled**

- 1.10 The Committee tabled two reports during the period 1 July 2021–30 June 2022:
  - Annual Report 2020-21 (tabled on 16 September 2021)
  - Making Hope Practical: Report of the inquiry into the response of Western Australian schools to climate change (tabled on 23 June 2022)

# *Making Hope Practical:* Report of the inquiry into the response of Western Australian schools to climate change

- The inquiry into the response of Western Australian schools to climate change reviewed the current frameworks governing climate action and sustainability in schools and identified areas for improvement. The report also sought to 'make hope practical' by collating evidence on the co-benefits of climate action in schools and featuring examples of successful and cost effective responses to climate change in schools.
- 1.12 The report found that the many and varied co-benefits of climate action in schools provide a strong justification for promoting and funding climate action in schools. Leadership from both the Department of Education and within schools is critical to implementing a whole-school approach to sustainability and climate action, which encompasses both material and immaterial responses.
- 1.13 The Committee made various recommendations on how the Department of Education and other government agencies can fully support climate action in schools, including additional funding and building capacity in teachers and other staff through targeted professional development. The government response to the recommendations was tabled on 18 October 2022.

#### **Other Activities**

The Committee conducted several other hearings to review the outcomes and administration of the agencies within its portfolio responsibilities, and to gather information to inform possible future inquiries.

#### **Department of Health**

The Committee conducted an agency review hearing with the Department of Health on 4
August 2021. Matters discussed included Western Australia's response to the COVID-19
pandemic, implementation of the recommendations of the sustainable health review and
the climate health inquiry, and the evaluation of the health promotion strategic framework.

#### Dr Tarun Weeramanthri

The Committee invited Dr Weeramanthri to a hearing on 6 August 2021 to give evidence on the findings and recommendation of the world first Climate Health WA Inquiry, which was completed in November 2020. This inquiry reviewed the current planning and response

capacity of the health system in relation to the health impacts of climate change, and considered areas for improvement in respect to climate change mitigation and public health adaptation strategies. Dr Weeramanthri's evidence was influential in the Committee's decision to undertake its inquiry into the response of Western Australian schools to climate change.

#### **Professor Peter Klinken AC**

1.17 The Committee invited Professor Peter Klinken AC, Chief Scientist of Western Australia, to discuss challenges facing the education sector, including Western Australia's universities, the state's response to the COVID-19 pandemic, and the future health research and innovation fund.

#### **Mental Health Commission**

1.18 The Committee conducted an agency review hearing with the Mental Health Commission on 11 August 2021. Matters discussed included the mental health impacts of the COVID-19 pandemic, governance changes within the commission, alcohol consumption and youth mental health services.

#### Work in progress

- On 7 April 2022, the Legislative Assembly requested that the Committee commence an inquiry into the Esther Foundation and unregulated private health facilities. This was in response to complaints and allegations concerning the faith-based women's residential rehabilitation facility that were reported on in the media and brought to the attention of the Hon Simone McGurk, Minister for Child Protection; Women's Interests; Prevention of Family and Domestic Violence; Community Services.
- 1.20 The inquiry will consider the complaints and allegations from former residents, staff and volunteers, and the adequacy of actions taken by the organisation to address those concerns. It will also consider relevant regulatory and legislative frameworks to determine how oversight of unregulated private health facilities could be improved.

## **Chapter 2**

### **Financial Statement**

- The Committee does not have its own formal budget and is funded out of the budget of the Legislative Assembly. Approval for major expenditures is required on a case-by-case basis and is entirely at the discretion of the Speaker.
