Dear Alanna,

Re: Non-Government Business

I write following the cancellation of two weeks of Non-Government Business in September 2022 as a result of the cancellation of State Parliament upon the death of Her Majesty Queen Elizabeth II and the subsequent public holiday.

The result was a loss of Non-Government Business (NGB) on the 15th of September for the Liberal Party and on the 22nd of September for the National Party.

As a team we noted that the 22nd of September was the last scheduled NGB assigned to the National Party while the Liberal Party still had four NGB opportunities on the schedule. In the interest of fair play the Liberal Party team readily agreed to give one of those opportunities to the National Party.

Following this we received correspondence from Grant Hitchcock from your staff outlining a reviewed allocation of NGB, and given that we had already agreed to donate one, we the Liberal Party are in full accordance with the proposal to reschedule October 27th as a National Party Non-Government Business opportunity.

I would therefore ask you to adjust the Non-Government Business schedule accordingly.
