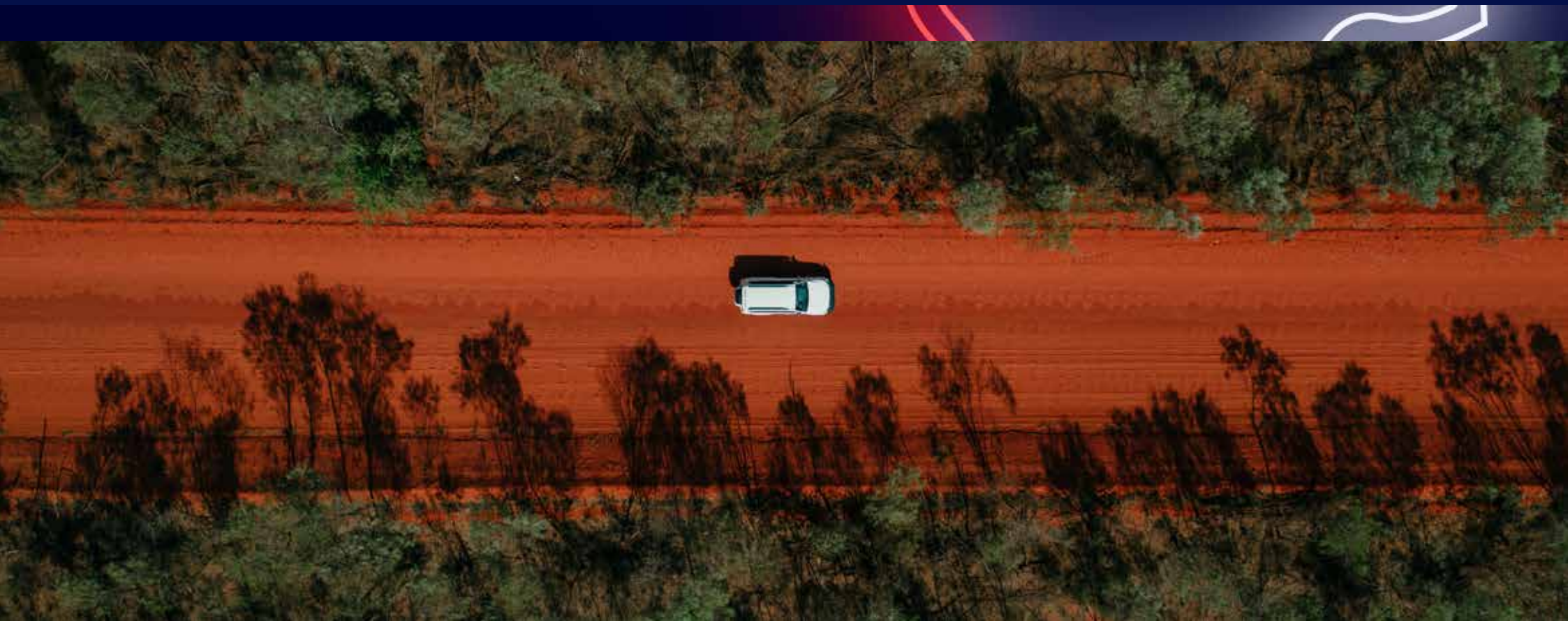

Minister's foreword

This is the fifth annual report produced by the Department of Jobs, Tourism, Science and Innovation's (JTSI) WA Industry Link on the implementation of the *Western Australian Jobs Act 2017* (the Act) and the Western Australian Industry Participation Strategy (WAIPS) since their launch in March 2018 and full application in October 2018.

The document, like its predecessors, provides detailed information on activities undertaken and outcomes achieved in 2021-22. There is no doubt that the Act and WAIPS have continued to play a key role in facilitating local supply to government agencies, particularly in the context of COVID-19 recovery.

The Western Australian Government also finds the data generated by reporting under the Act and WAIPS to be highly significant, both in terms of measurement of effectiveness and in mapping contract award decisions in relation to expenditure type and location of activity.

It is noteworthy that the functioning of the Act and WAIPS is based on the Government's belief in the competitiveness, capacities and

capabilities of Western Australian-based suppliers and the correlation between local submissions and lowest conforming bid. There is, consequently, a primary emphasis on a consistent policy and process environment which provides full, fair and reasonable opportunity for local suppliers to submit quote and tender submissions.

A properly functioning market is therefore essential to this approach and this is also reflected in the focus of the Procurement Act and the Western Australian Buy Local Policy.

Regular consultation with industry, industry bodies, trade unions, suppliers and agencies is necessary for attaining and maintaining an open market approach. The comments and suggestions received through consultations in 2021-22 were essential to the development and release of the Buy Local Policy (April 2022) and updates to the current version of WAIPS. Details of these updates are provided later in this report.

Consultation is especially important to Government at a time of rapid change in emerging industries, including renewable energy and emission

reduction, use of digital technology and innovation as a driving force for economic diversification and workforce skilling issues. The future role of Government procurement, in terms of supporting these issues, is a priority for 2022-23 and beyond, and in this way our approach to ensuring the economic and social objectives at Government procurement continues to evolve.

Executive summary

In 2021-22, the *Western Australian Jobs Act 2017* and WA Industry Participation Strategy (WAIPS) maintained momentum across a range of applications and activities.

The WA Industry Link Portal continued to be a source of policy advice to small-to-medium sized enterprises (SMEs) and Agencies while, also functioning as a means of promoting relevant events such as the Regional Business Engagement Forums (Forums).

In 2021-22, 11 Forums were delivered across the State. The Forums provide SMEs across Western Australia with information regarding upcoming local contract and tender opportunities in their respective regions, policy and process modifications and assistance available to businesses.

The scope of WAIPS expanded with progress on the application of the Strategic Project concept to Stand-alone Power Systems and the new \$1.8 billion Women and Newborn Hospital.

Enhancement of local SME competitiveness also continued through the JTSI Local Capability Fund (LCF). Three rounds of the LCF were launched during 2021-22: Supplying Key Major

Projects, Aboriginal Business and National and International Standards Compliance. These rounds resulted in \$2.1 million in funding being provided to 62 WA companies.

Industry Link Advisory Service

Western Australian Industry Participation Strategy (WAIPS)

In 2021-22, 11,185 jobs were supported in Western Australia, including 3,075 in the regions. Local sourcing of 94.33 % was also achieved. In addition, it is estimated that WAIPS supported more than 982 apprenticeships and traineeships in Western Australia, including 290 in the regions.



Western Australian Buy Local Policy 2020

In April 2022, an updated version of the policy was released by the Deputy Premier.

Enhancements included modifications to the application of regional price preferences and the value for money approach. Over the year, the number of key agencies with Buy Local Policy Implementation Agreements reached 40.

The WA Industry Link Portal

In the last 12 months, the Portal has been accessed a total of 35,719 sessions. The most accessed pages include the LCF, WAIPS and Participation Plans.

The Portal continues to act as a critical mechanism for both SME suppliers and agencies in understanding important Government initiatives including the WAIPS, the WA Buy Local Policy and accessing funding opportunities like the LCF.

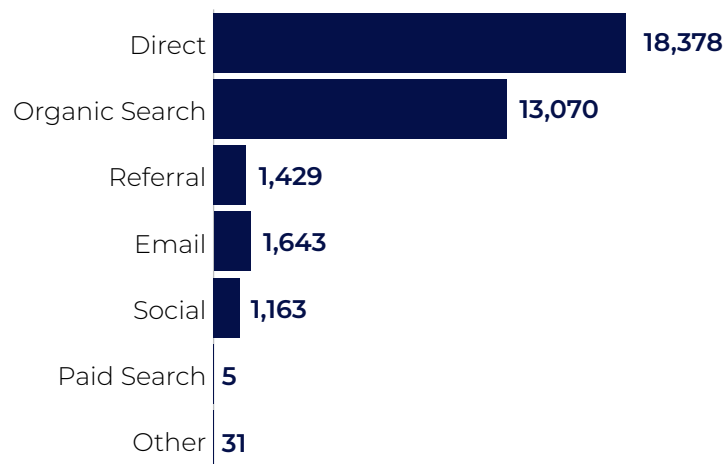

Strategic projects

METRONET Railcar Program

Alstom had 103 staff in Western Australia and a further 62 subcontractors in the State working directly on the project. There are also a total of 11 apprentices working on the project.

The total project spend was \$132.5 million to 30 June 2022, with Alstom on track to meet the 50.06% WA local content target.

Alstom has a total of 28 subcontractors providing WA local content including local supplier, Parker, who has set up manufacturing capabilities in Welshpool producing braking, piping, pneumatic piping and connectors.

Alstom continues to work with its facilities management subcontractor, Programmed, in sourcing local Aboriginal business to provide a range of services including cleaning, fire and equipment service and management, general maintenance and repairs, supply of first aid equipment and electrical tag and testing.

Stand-alone Power Systems (SPS)

JTSI worked with both Horizon and Western Power in guiding and capturing sourcing outcomes for this emerging means of energy storage and distribution.

A number of Western Australian based companies are producing SPS units characterised by use of local inputs wherever feasible. Installation and maintenance in the regions of SPS units represents a new market across the State.

Women and Newborn Hospital

JTSI is a member of the project control group overseeing the new \$1.8 billion project which is anticipated to create 1,400 jobs during construction. The use of participation plans for various key aspects of the project will strengthen the emphasis on local supply.

Regional summary

There were a range of strategies operating in regional WA which were linked to the Act and WAIPS in terms of realising beneficial economic and community outcomes.

For example, as part of the post COVID-19 recovery package, the May 2022 Budget included a \$12 billion commitment to regional infrastructure provision. The allocation of \$662 million to the Collie Just Transition strategy and \$80 million to forestry for similar purposes also

illustrates the need for effective policy and process in terms of stimulation.

The impact of the move to renewable energy was also a significant and growing consideration for regional businesses in terms of both internal operations and market opportunities. A similar comment can be made with regard to the advent of digital technology as a generator of productivity and new demand.

Part of JTSI's role was to conduct Forums in conjunction with the Local Capability Advisors Network, the Department of Finance and the Department of Communities, which outlined opportunities and assistance available to realise potential. Valuable feedback was received from attendees and Regional Chambers of Commerce WA on enhanced policy and processes.

New Initiatives

SMEs Training - Doing Business with Government

In 2021-22, WA Industry Link continued with the delivery of the Regional SMEs Workshop Program.

A total of 10 workshops were delivered across regional WA, ranging from Broome in the Kimberley, to Geraldton in the Mid-West, to the Wheatbelt towns of Moora and Narrogin, east to the Goldfields and south to collie, Dunsborough, Albany and Katanning.

The 3-hour workshops were delivered by a local consultant, Procurement Plus, which has extensive experience in government procurement and also private industry.

Through the workshops, participants were provided with information that gave them a better understanding and appreciation of:

- » current government policy and legislation as it applies to procurement
- » underlying procurement principles
- » procurement processes and how responses are assessed by government
- » how to respond to procurement requests i.e. tenders and quotes.

Participants also had access to the presenter for 3 months after the workshop to assist them with any questions or provide further support when they were trying to respond to government procurement processes.

In 12 months, approximately 80 businesses attended the 10 workshops. Post workshop surveys were conducted and it was overwhelmingly (94%) found that the workshops were 'good' or 'very good,' i.e. the two highest ratings for the post workshop survey. The remaining 6% of attendees still rated the workshop as satisfactory.

The city campus project is progressing, supported by additional funding from Commonwealth and State sources. JTSI has maintained its role in terms of facilitating process which realises local benefit in terms of employment and business.

ICT Procurement

In 2021-22, JTSI hosted four ICT Consultative Forums. The forums continued to function as an important mechanism in promoting public/private sector information exchange and collaboration. Digital technology skill requirements, procurement arrangements and promotion of digital technology take-up by SMEs and regional business were priorities.

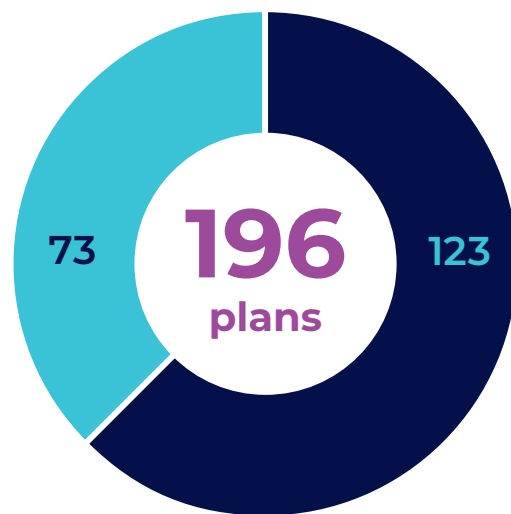
Social Procurement Framework alignment

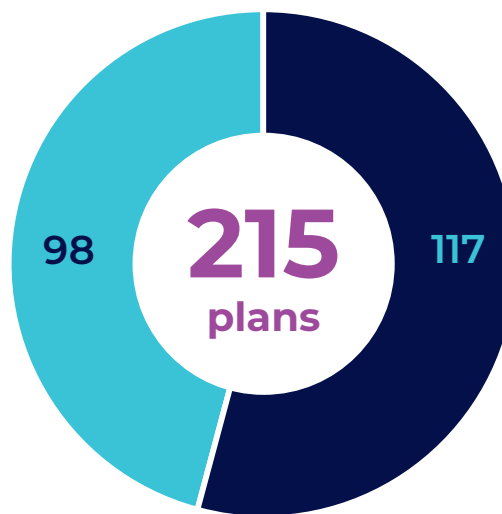

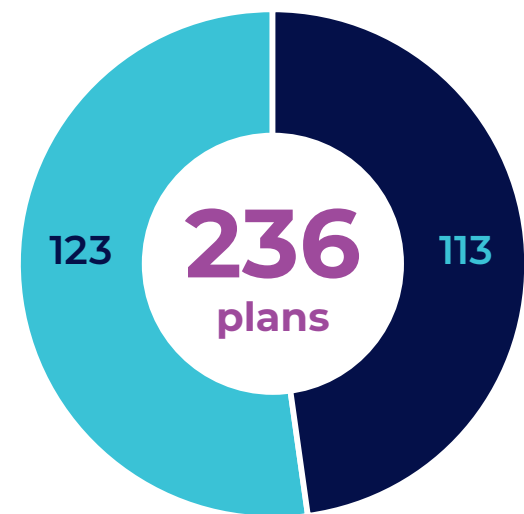
Number of awarded tenders that required a participation plan

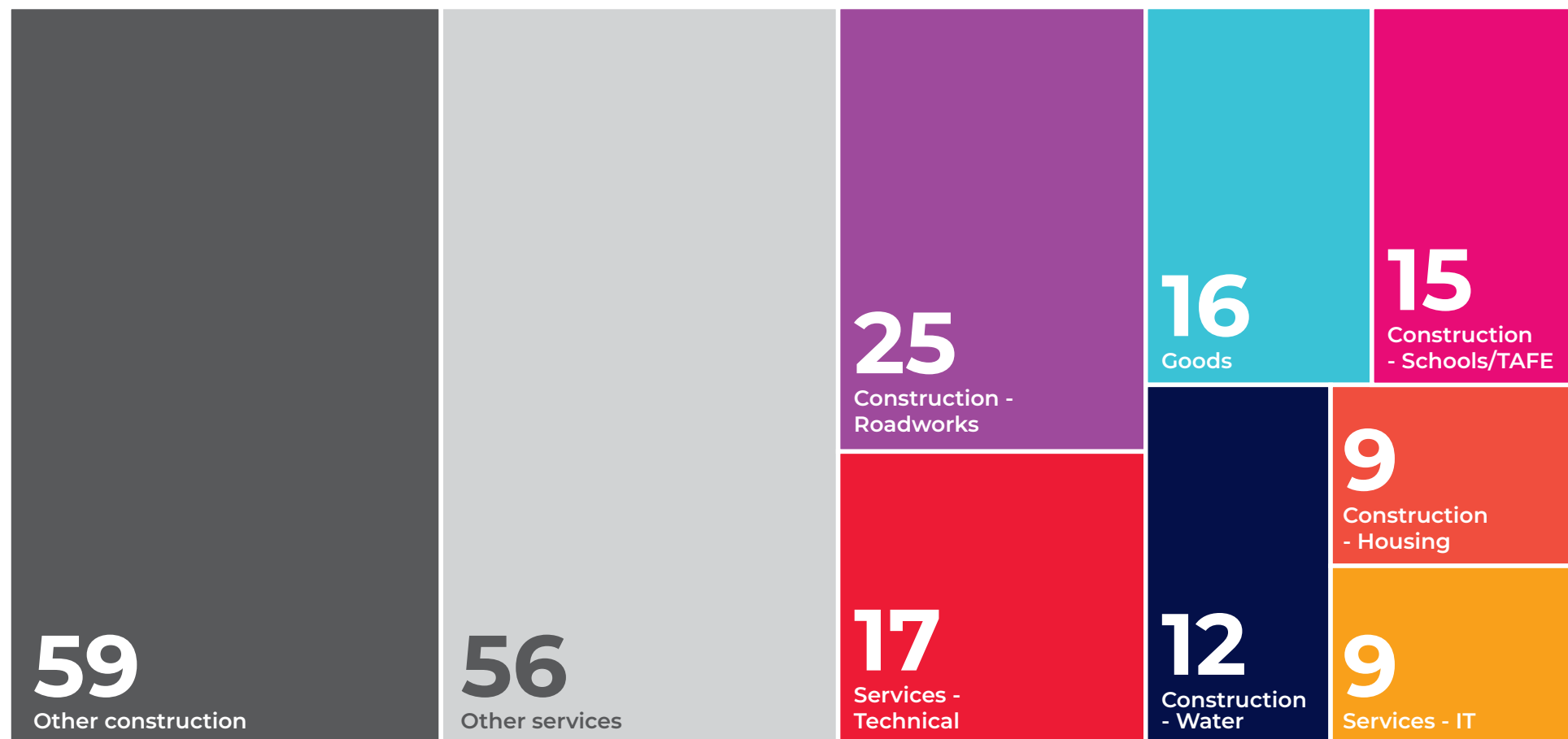

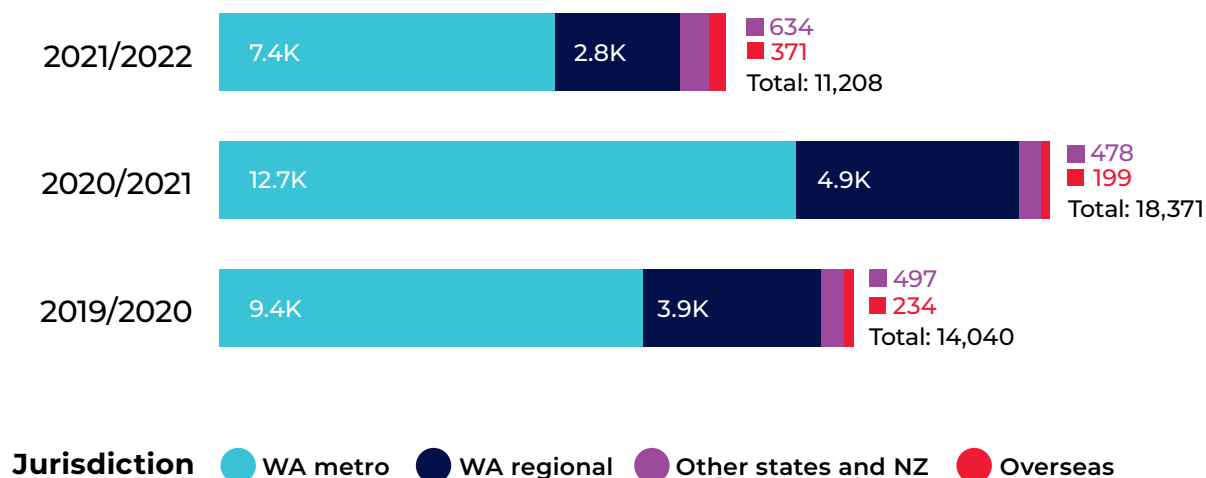

Number of awarded tenders (that required a participation plan) by Work Type

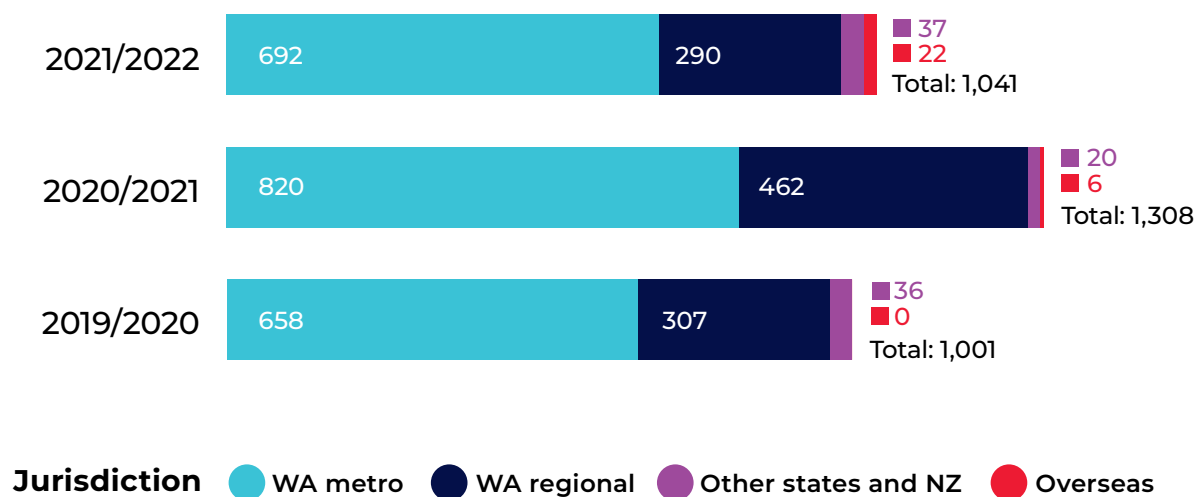


Total estimated workforce including apprentices and trainees

Estimated workforce (excl. A&Ts)

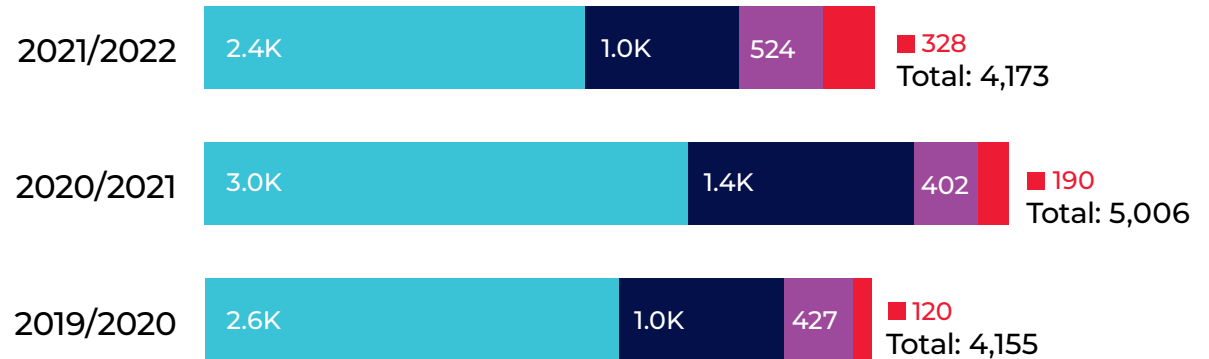


Estimated apprentices and trainees



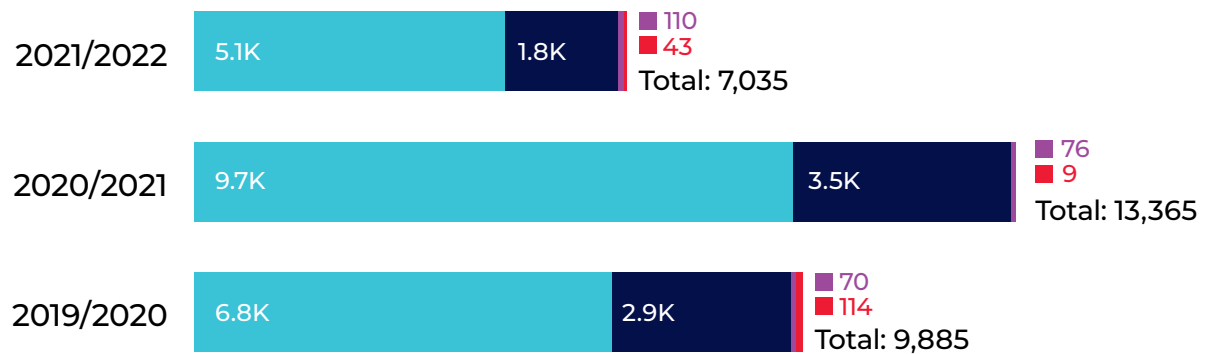

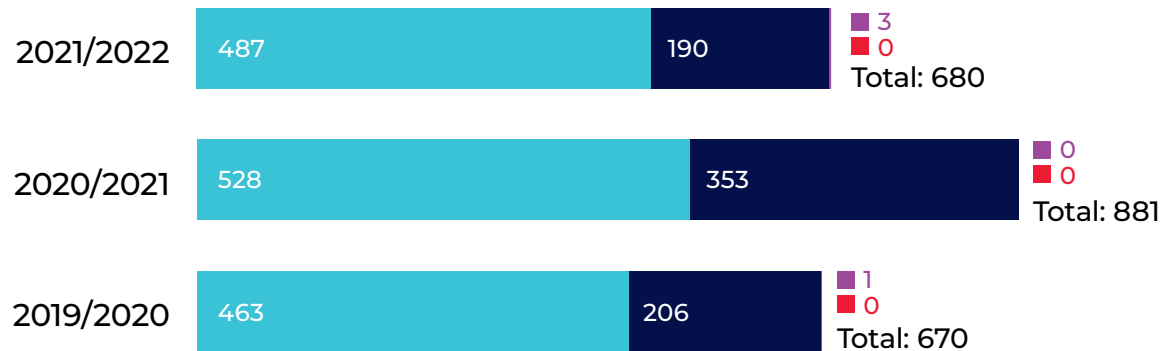

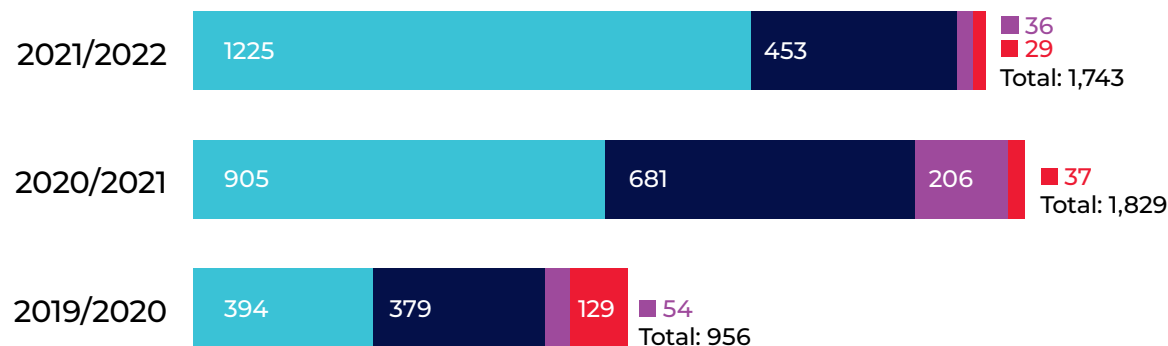
Estimated subcontractor apprentices and trainees

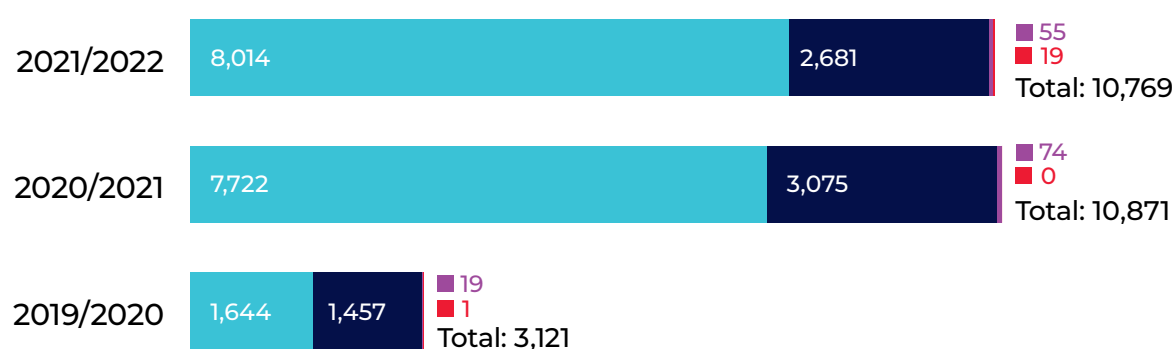
Actual workforce, apprentices or trainees

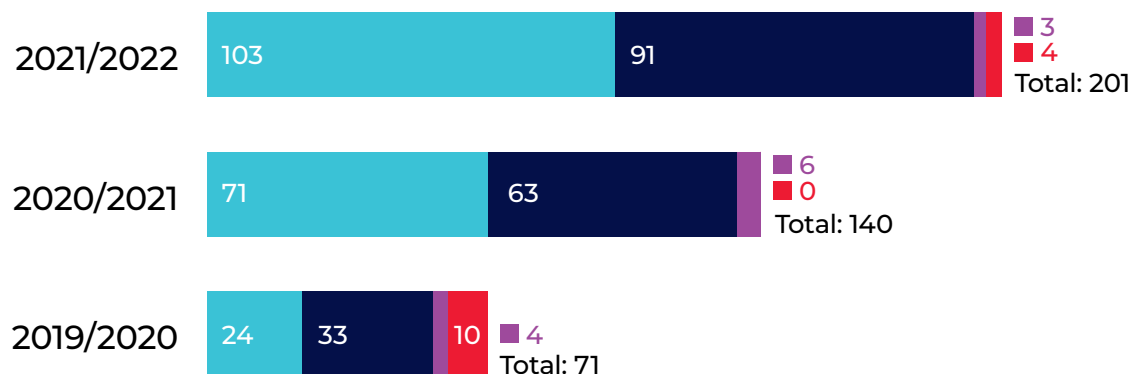
Actual subcontractor workforce (excl. A&Ts)

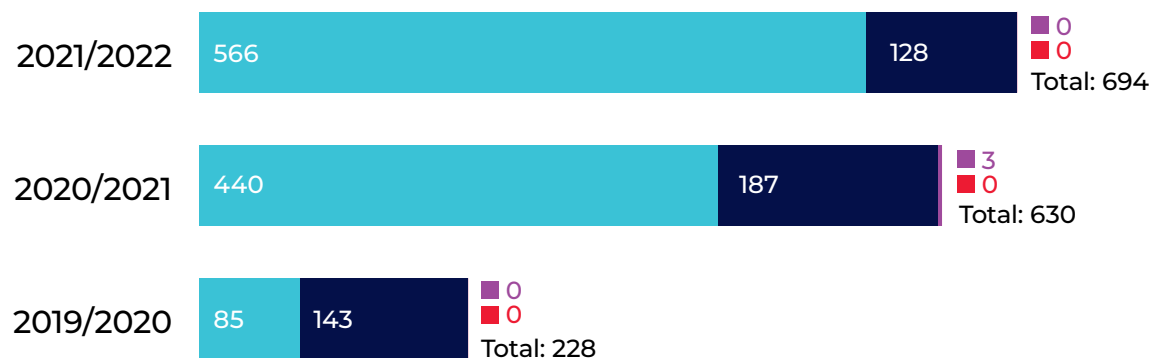

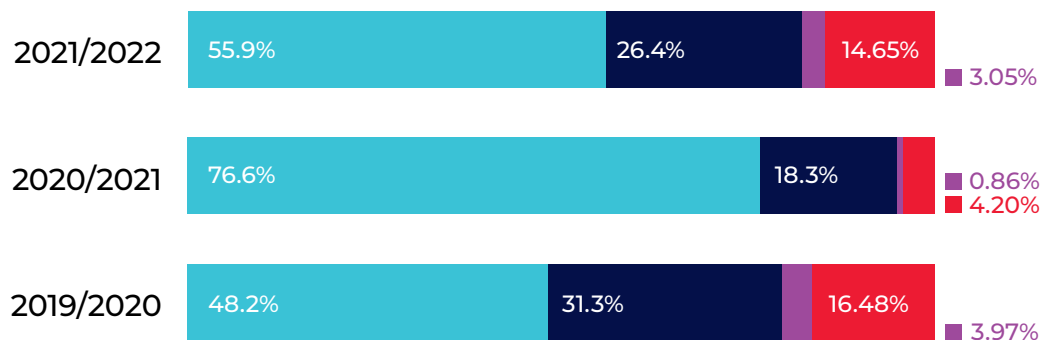
Estimated spend - Housing and works

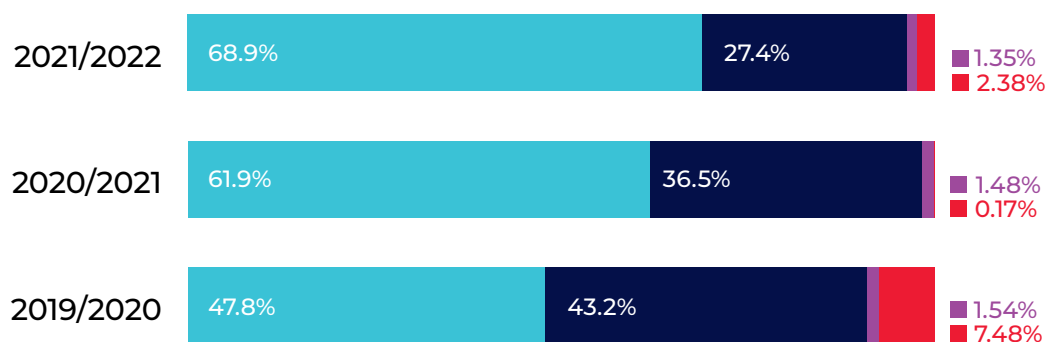
Actual spend
